TRUSTEES' REPORT

The Board of Trustees presents its report with the unaudited accounts of The Message of The Cross-Evangelical Church for the year ended 31 December 2024. The financial statements have been prepared in accordance with relevant accounting policies and in compliance with the charity's governing document and applicable law – the Charities Act 2011 and the Charities (Accounts and Reports) Regulations 2008.

Name and Objects

The Message of The Cross-Evangelical Church is a registered charity in England and Wales, number 1177259. The Trustees are responsible for the governance of the charity and serve as Trustees of the charity. The Trustees who were in place at year-end and all those who served during the year are listed above.

Structure, Governance and Management

The Charity governing document is a CIO registered on February 21, 2018. The Charity is governed by a board on which the trustees are represented. The board members meet regularly to plan activities to be undertaken by the church, review and compare the actual achievements with the plan and monitor the financial position of the church.

Objectives and Activities

The objective of the charity is to meet spiritual and physical need of its congregation and a wider community. To advance the Christian religion by organising, providing, and developing church services and religious activities. The charity's main purpose is transforming the community through holistic ministry. We worship God, having a fellowship with each other and committed to serve the community. Our focus is on lonely and disadvantaged group in the community. We give advice, building up trust with people, and walking with them. The church also provides pastoral care, spiritual and moral development, both for the congregation and for anyone else who wishes to benefit from what he church offers.

Achievements and Performance

The organisation continues to hold Christian worship services in the community. This has produced satisfactory results in reaching and helping members of the community. The

organisation also held its weekly church services that brought great emotional and spiritual support to members of the community.

Though we are not back to the level of activity before Covid-19, we have observed that the impact of the Covid-19 has started to decrease in terms of number of participants and number of face-to-face programmes instead of zoom. This year we have seen more church members than the previous four years.

During the year we have celebrated our 10th year anniversary. This program brings our church members together to have a special prayer and a sense of togetherness.

The organisation has engaged in improving and strengthening the relationship between different community groups and we are planning to offer our prayer and bible study program in English language. The challenge to secure grant from government and other bodies restricted our effort to reach out to the wider community.

FINANCIAL REVIEW

The income of the charity is above £ 10000.00. The charity income and costs have been managed well over the financial year. The charity's main costs are rent, gifts and donation for accomplishing the church's main activities (bible studies and prayer programmes). The substantial amount spent as gifts and donation was made during the 10th anniversary celebration time. We have rented a hall so that we can conduct our programmes in an appropriate way and convenient place.

RESERVE POLICY

It is the policy of the Charity to maintain unrestricted funds, which are the reserves of the charity at about three months of unrestricted expenditure. This provides enough funds to cover any emergency expenditure that may arise from time to time. The charity will seek to maintain this level throughout the year.

RISK MANAGEMENT

The charity has assessed all the major risks to which the charity is exposed to, those related to operations and finances of the charity and is satisfied that systems are in place to mitigate exposure to major risks.

TRUSTEE RESPONSIBILITIES
