Review of financial position

The Charity financial statement has been prepared in accordance with the requirements of the Statement of Recommended Practice (SORP), 2005.

For the financial year ended 31st December 2022, total income resources amounted to £12,952 and includes the total of tithes and offering, and donations from members. This was mainly spent in the fulfilment of the charity's day to day activities and total expenditure amounted to £9,678. Surplus of income over expenditure for the year ended 31st December 2022 amounted to a deficit of £3,274 and a cash balance of £4,363.
