Trustee Report for the period 1st March 2021 to 31st March 2022

Aims and Activities

Our activities were constrained by the Covid15 pandemic but we took the opportunity to broaden our community involvement in related charitable activities.

We continued to provide a place of worship patterned on the bible, both the tanach (Old Testament) and the brit hadasha (New Testament). This activity was reduced due to Covid19 but continues with regular Zoom meetings

We support 'FULLHRH', a weekly activity feeding the unfortunate, Lost, Lonely, Hungry, Homeless and rough sleepers at various locations in Plymouth. feeding program for

We were active at Derriford Hospital through regular ward visits and a role in 'end of life' chaplaincy support.

David has been active as a Chaplain at Devon and Cornwall Police visiting a large station in Plymouth and Role playing in police training courses at HQ. David was on-site as chaplain during the Keyham shooting incident. David resigned from Devon and Cornwall police in November 2021.

David undertook training in Emotional Logic was provided by ???

David took up a chaplaincy role in December in the Keyham and Ford wards with the support of the local authority. We established good relations with a local school in Keyham and with several local churches.

We are involved in the local Neighbourhood Watch, working together with local Councillors, the police and Plymouth City Council. We respond to requests for help and advice from local residents on issues such as noise, speeding vehicles, fly tipping, li er, road maintenance, inconsiderate parking, and more. We co-operate with other organizations in community outreach and social and charitable activities.

We remain accountable to Tikkun International in Israel and are members of the International Fellowship of Messianic congregations and synagogues (IAMCS). We are part of Churches together in Plymouth and Churches together in Devon.

We are waiting to renew activities with the Plymouth Centre for Faiths and Cultural Diversity (PCFCD) in order to address the statutory requirements of the 2014 "Engaging With Religion and World Views" Agreed Syllabus for Religious Educa4on, through lively and creative learning.

Declared Aim and Purpose

The trustees have the responsibility of co-operating with the ordained leader, David Wright, an emissary ordained by Tikkun International in promoting a first century model of congregations of Jewish and gentile believers in the Messiah Yeshua (aka Jesus) in Plymouth to be known as 'Beit Ezra Messianic Congregation'.

Messianic Judaism is a movement that is people focussed and 'Beit Ezra' exists to benefit the public at large and not just a like minded congregation.

From the outset, before registration as a charity, Beit Ezra has been involved in the community. Registration as a charity has enabled us to further that involvement.

Objectives and Activities

We operate to benefit the public both in spiritual terms but also to have regard to the practical needs of our community. We co-operate with other organizations in outreach and social and charitable activities.

Congregation

As a congregation Beit Ezra is charged to provide a place of worship patterned on the bible, both the tanach (Old Testament) and the brit hadasha (New Testament). We provide a safe and non-threatening environment for Jewish and gentile enquirers into the Jewish roots of Christianity.

We are part of Tikkun International and are accountable to their leadership. We are members of the International Fellowship of Messianic congregations and synagogues (IAMCS).

At the start of the Covid-19 pandemic we continued to meet in a local church hall following the government conditions. When this proved too restrictive and attendance dropped significantly we met on-line using the Zoom utility.

We have continued to welcome all people regardless of race, age, gender, religion including no religion

Beit Ezra in the Community

We see Beit Ezra as part of the wider church in Plymouth, and we are listed on the Churches Together in Plymouth website.

We are active in 'Churches together in Plymouth Prayer'. During the pandemic we have met on Zoom with a number of other believers from many other congregations on a Wednesday morning to pray for the City of Plymouth. We have speakers from the various churches as well as Council officials, the police, and the various faith community organizations.

Feeding the hungry: We support an activity in the community that provides food for those classed as unfortunate, Lost, Lonely, Hungry, Rough sleepers and Homeless.

Hospital Pastoral visitor- NHS Derriford Chaplaincy we were unable to continue this activity due to Covid-19 restrictions

Police Chaplaincy- David Wright continued as the chaplain at Charles Cross Police station in Plymouth. Police chaplains are a non-judgemental, listening ear for anyone in the station including officers, staff, volunteers and also the family members of those serving in the police

Plymouth Centre for Faiths and Cultural Diversity (PCFCD) has successfully created thousands of opportunities for children and young people to meet speakers from a variety of faiths and cultural backgrounds in schools and other settings. These encounters allow children to experience the reality of religion as a way of living life and identify the values that all religions teach, thus enabling schools to address the statutory requirements of the 2014 "Engaging With Religion and World Views" Agreed Syllabus for Religious Education, through lively and creative learning. David Wright is one of these speakers but has not been active due to Covid-19 restrictions.
