Meetups

The majority of the YorkDevelopers community groups used meetup.com in order to advertise and allow people to sign up to the events.

Some of the groups (such as .net York) get their meetup accounts from their parent foundations.

Other groups such as YorkCodeDojo, CodeAndCoffee and YorkGamesDev are being funded by the charity.

Due to Covid the charge for our meetup account was waived this year.

Affiliated Groups

At present the YorkDevelopers charity hasn't taken any income or funded the local groups. It is our aim that in the future that the charity will be able to provide some resources such as projectors or video recording equipment.
