DURING THE PERIOD THE TRUSTEES SUPPORTED THE APPEAL FOR ORPHANS, WIDOWS AND HARDSHIP PROJECTS FOR POOR BENEFICIARIES IN MALAWI, AND HAVE BEEN WORKING IN MALAWI TO SUPPORT POOR PEOPLE WITH FOOD PACKS, THE BUILDING OF FACILITIES FOR CURRICULUM SUBJECTS, AS WELL AS VOCATIONAL SUBJECTS, AND ISLAMIC EDUCATION CLASSES. THE PROJECTS OF THE CHARITY HAVE BENEFITTED OVER 2,000 PEOPLE AND AT THE END OF THE PERIOD THE CHARITY HAVE PART-COMPLETED THE MUTLI-USE EDUCATIONAL FACILITIES FOR THE USE OF THE COMMUNITY IN MALAWI.

THE TRUSTEES HAVE HAD DUE REGARD TO THE GUIDANCE OF THE CHARITY COMMISSION ON PUBLIC BENEFIT AND ARE SATISFIED THAT THEY ARE ACTING IN ACCORDANCE WITH THAT GUIDANCE IN RELIEVING FINANCIAL HARDSHIP, ADVANCING EDUCATION AND ADVANCING ISLAM FOR PUBLIC BENEFIT.

Summary of the main achievements of the charity during the year

DURING THE PERIOD THE TRUSTEES SUPPORTED THE APPEAL FOR ORPHANS, WIDOWS AND HARDSHIP PROJECTS FOR POOR BENEFICIARIES IN MALAWI, AND HAVE BEEN WORKING IN MALAWI TO SUPPORT POOR PEOPLE WITH FOOD PACKS, THE BUILDING OF FACILITIES FOR CURRICULUM SUBJECTS, AS WELL AS VOCATIONAL SUBJECTS, AND ISLAMIC EDUCATION CLASSES. THE PROJECTS OF THE CHARITY HAVE BENEFITTED OVER 2,000 PEOPLE AND AT THE END OF THE PERIOD THE CHARITY HAVE PART-COMPLETED THE MUTLI-USE EDUCATIONAL FACILITIES FOR THE USE OF THE COMMUNITY IN MALAWI.

Financial review

Brief statement of the charity's policy on reserves

DURING THE PERIOD THE TRUSTEES SECURED AN INCOME OF £168,739 WHICH WAS HIGHER THAN PRIOR YEAR (£145,953) FROM DONATIONS TO THE GENERAL FUND AND SPECIFIC PROJECTS. A TOTAL OF £146,126 (2021:£188,271) WAS SPENT, WITH £133,555 SPENT ON GRANTS AND DIRECT CHARITABLE EXPENDITURE. ALL RESTRICTED DONATIONS FOR PARTICULAR PROJECTS AND ZAKAAT PROJECTS HAVE BEEN SPENT DURING THE YEAR. THIS GENERATED A SURPLUS FOR THE PERIOD OF £22,316 WHICH WAS ADDED TO PRIOR YEAR SURPLUSES. AT THE END OF THE PERIOD THE CHARITY HELD £44,572 IN RESERVES WHICH WILL BE UTILISED FOR FUTURE CHARITABLE EXPENDITURE, ESPECIALLY IN THE COMPLETION OF THE BUILDINGS PROJECT. THE TRUSTEES DO NOT HAVE A POLICY TO RETAIN RESERVES WITHIN THE CHARITY, BUT ANY SURPLUS HELD WILL BE USED FOR FUTURE CHARITABLE EXPENDITURE FOR PROJECTS THAT WILL BE DELIVERED IN THE COMING YEAR. ALL THE RESERVE FUNDS HELD ARE UNRESTRICTED.


