The Trustees of The Cheam Foundation present their annual report and financial statements for the year ended 31 August 2023 and confirm that they comply with the requirements of the Charities Act 2011, as amended by Charities Act 2011, the Charities SORP (FRS 102) and the Constitution of The Cheam Foundation (Governing Document).

THE CHEAM FOUNDATION YEAR ENDED 31 AUGUST 2023

BACKGROUND AND CONSTITUTION

The Cheam Foundation is a charity that exists to support present and future generations of pupils at Cheam School. It was established in 2018 by Governors, staff and parents of Cheam School.

The Cheam Foundation was incorporated on 11th April 2018 as a Charitable Incorporated Organisation registered with the Charity Commission (Registration Number 1177913).

AIMS AND OBJECTIVES

The Cheam Foundation exists to ensure continuing investment in the school's facilities and to provide vital funding for life-changing, means tested Bursaries for children from low-income families. The Cheam Foundation helps the school to realise its ambitions and make a real difference for generations to come.

All funds raised are ring fenced and kept separate from main school finance and The Cheam Foundation acts as a vehicle for collecting, holding/investing and dispensing sums donated for the benefit of the school.

ORGANISATION AND MANAGEMENT

There is an independent body of Trustees comprised of Governors, parents and past parents of the school. The Trustees must hold at least 3 meetings per year. Cheam School have been delegated responsibility of the operations of The Cheam Foundation by the Trustees but are not remunerated by The Cheam Foundation.

RISK MANAGEMENT

Trustees are aware of their responsibility to manage risk. Strategies used to ameliorate and minimise risk are:

- Provision of a clear investment strategy.
- Proper authorisation of expenditure.
- Annual audit.

ACTIVITIES AND FINANCIAL REVIEW

The Cheam Foundation has had a positive year and has made a valued contribution towards the school, as well as continuing to build a long-lasting alumni community. In addition to the gifts and pledges received, the Cheam Foundation increased the number of people who support its work by attending events, making individual donations and making provision for the Foundation in their Wills.

The primary focus during 2022-2023 has been to raise money for The Cheam Foundation Bursary Fund, in order to enable more children from low-income families to attend the school. The Cheam Foundation also financed a new facility in the school grounds called the "Year 8 Retreat", which was completed and in use by current pupils in April 2023.

During the year gross income was £170,652. During the year, The Cheam Foundation made grants (from income) of £87,461 directly to The Cheam School Educational Trust, by way of payment for school fees for three Bursary recipient children. The Cheam Foundation also made a grant (from income) of £47,114 directly to The Cheam School Educational Trust to finance the build of the new "Year 8 Retreat" in the school grounds.

PLANS FOR THE FUTURE

The Cheam Foundation plans to continue to raise funds to provide life-changing Bursaries for children from low-income backgrounds, as well as fundraise for Capital Projects, as and when approved by the Headmaster and Governors, which are intended to extend the facilities at the school.

RELATED PARTY TRANSACTIONS AND CONNECTED ENTITIES

The Cheam Foundation salaries, operational costs and expenses were funded by Cheam School.

RESERVES

The purpose of The Cheam Foundation is to support the school by raising funds for capital projects and bursaries as noted above. Its operational costs are met by Cheam School.

In addition to the general discretionary fund, various sub funds have been set up for specific projects, for example The Bursary Fund. In this way the Trustees can make sure that donations are applied for the purpose for which they were donated.

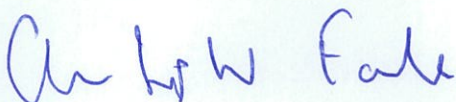
STATEMENT OF TRUSTEES RESPONSIBILITIES
