Trustees Report for year ended 05 April 2025

The Trustees of Coldfall Support present their report and the financial statements of the Charity for the year ended 05 April 2025. The financial statements have been prepared in accordance with the Charities Act 2011 Section 133, using the Receipts and Payments basis available to small charities.

Charity Details

A list of names and addresses of the charity principal officers and bankers is set out on page 1.

Objectives

The charity's objective is to advance for the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing by maintaining, carrying on, managing and developing a school offering a broad and balanced curriculum.

Organisation

Coldfall Support is governed by a board of Trustees who are elected to serve the school and run its affairs. Annually the Board reviews the range of skills it has available and uses its power of co-option to ensure that gaps are filled. Trustees serve for a three-year term, when they may be re-elected by other trustees.

Risk and Internal Control

The Trustees review the main operational risks and take actions to manage or mitigate them accordingly.

Review of transactions and financial position

During the year, donations received through the direct transfer to NatWest bank and JustGiving Platform totalled £34,812.62. The donations received have been made available without restriction as to its usage.

The balance on the Charity's Funds are Unrestricted. These will be used to fund the Charity's objectives during the new financial year. The Trustees confirm that the Charity's assets are available and adequate to enable it to fulfil its obligations.

Statement of trustees responsibilities for the preparation of financial statements

Charity law requires the Trustees to prepare financial statements which show a true and fair view of the state of the charity affairs as at the year end and of the resources received and expended by the charity for the year then ended.
