Summary of the objects of the charity set out in its governing document

(1) The advancement of education for the public benefit in any part of the world by advancing and increasing individual and collective knowledge and understanding of the use of (*inter alia*) fresh plant material as a food source for exotic and domestic animals in captivity, in particular but not exclusively by collating research and published material and disseminating the same (including, without limitation, in the form of booklets, posters or online).

(2) The advancement of environmental protection and improvement including, in particular but without limitation, conservation of flora, fauna and the habitats thereof, and encouragement of biodiversity, including within and via reputable zoological collections.

(3) The advancement of charitable purposes (according to the laws of England and Wales) as the trustees see fit from time to time, in particular but not limited to advancing the conservation and/or welfare of flora, fauna and the environment generally including by the donation of funds.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

The sales of posters and booklets have continued although the pandemic caused a downturn in the sales and the Chair did not travel to any events in the whole of this financial year.

In April 2020, the Chair started research for a new booklet covering Herbs & Culinary Plants. This research is currently awaiting peer review before it can be sent to BIAZA for certification. Some work was also started on research for a booklet covering plant provision for rodents.

In June 2020, Sparsholt College approached the Chair asking her to write a chapter about browse provision in zoos. This chapter is used as part of the course material for the DMZAA (Diploma in Management of Zoo and Aquarium Animals).

In September 2020, the Chair and one of the other Trustees started a large project of building a mobile app for Browse Poster. When finished and launched, this app will help the user identify or search for a range of plants and get details about toxicity and other hazards as well as see feeding guidelines where applicable.

For this year's donation round, Browse Poster's followers were asked to nominate worthy organisations to receive a donation and a shortlist of 10 organisations was sent out for voting. The four organisations with the most votes would receive £250 each. This approach was a great success with 631 votes cast in total.

The trustees of the charity have had regard to the guidance on public benefit issued by the Charity Commission when exercising any powers or duties to which the guidance would be relevant.

Sumatran Rhino Rescue received £250.80 but the international transaction didn't go through in time for this financial year so will figure in the next year.

Mountain Marmoset Conservation Program was due to receive £250 as well but they have failed to provide payment information despite a number of requests.

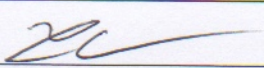
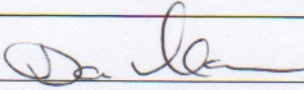
