- (1) The advancement of education for the public benefit in any part of the world by advancing and increasing individual and collective knowledge and understanding of the use of (*inter alia*) fresh plant material as a food source for exotic and domestic animals in captivity, in particular but not exclusively by collating research and published material and disseminating the same (including, without limitation, in the form of booklets, posters or online).
- (2) The advancement of environmental protection and improvement including, in particular but without limitation, conservation of flora, fauna and the habitats thereof, and encouragement of biodiversity, including within and via reputable zoological collections.
- (3) The advancement of charitable purposes (according to the laws of England and Wales) as the trustees see fit from time to time, in particular but not limited to advancing the conservation and/or welfare of flora, fauna and the environment generally including by the donation of funds.

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

The Chair decided not to travel to smaller workshops this year as the expenses were often higher than the income from sales at these events. The main event to attend continues to be the annual ABWAK Symposium.

The Behavioural Biology of Zoo Animals, which the Chair co-authored a chapter for, was published in the summer 2022.

A virtual presentation for Animal Concepts were completed in July 2022.

The forthcoming mobile app is unfortunately sitting a little dormant at the moment. Although it is finished enough for a public release, the platform provider has not yet released the function needed for the app to be locked in subscriptions. We have identified a different platform that might be able to offer the options we need. We are currently testing a free trial period to see if it will work, and we have received a verbal promise of a year's financial support from a UK company. That should be enough time to move the app to this new platform (if it works) and then launch it. Once launched, it should then be able to pay for itself through the subscriptions.

The Chair has been invited to attend a new event for keepers as an industry expert. The event will be taking place at Jimmy's Farm in September 2023 and is aimed at providing opportunities for keepers to gain new skills.

After talks with the Dutch/Belgian keeper association Harpij, an agreement was reached on a collaboration on a new flower booklet. The Chair has identified a range of flowering plant species, written toxicity information and sent it all together with ID pictures to Harpij. They have now started the process of translating the content and will design the layout of the booklets.

The biggest obstacle this financial year has been the enforcement of new custom rules after Brexit. Due to ongoing challenges getting parcels to overseas customers, sales to countries outside the UK was temporarily suspended until a suitable solution was identified. We think we have now found a solution at no extra costs, and the sales outside UK has been opened up again.

This year's donation round wasn't quite as dramatic as last year's with a humbler number of organisations nominated. Due to limited income in 2022/23, only one organisation received a donation of £250.

The trustees of the charity have had regard to the guidance on public benefit issued by the Charity Commission when exercising any powers or duties to which the guidance would be relevant.
