Accounts

Trustees Report for 2025/26

The 2025/26 season has been another year of significant progress and consolidation for Glossop North End Community Club, building on the successful establishment of the Glossop Community Sports Hub and the continued growth of the Club's activities and community impact.

The Club now supports over 600 members across 46 teams, providing football opportunities from the age of two through to walking football and veterans' football. Our offer continues to extend beyond traditional competitive football, with an expanded programme of accessible and inclusive activity including pay-and-play sessions, holiday camps, recreational bookings and football provision for home-educated young people. These initiatives have enabled the Club to engage with a broader cross-section of the local community and further deliver against its charitable objectives.

The girls' and women's section has continued to grow significantly and remains a strategic priority. The Club now offers teams at every age group, providing a clear participation and development pathway from youth football through to adult involvement. This includes a Women's First Team, flexi women's teams, and a Women's Veterans team, ensuring that opportunities exist for women and girls of all ages and abilities to participate in football within a supportive and inclusive environment.

Partnership working continues to underpin the Club's success. Strong relationships have been maintained with New Mills Juniors, Hayfield Juniors, and Glossop Rugby Club, alongside wider community use of the Sports Hub. The Club has also strengthened its partnership with the High Peak Schools Sports Partnership, hosting a range of positive participation events including SEND sessions, High Peak school finals, and other school-based activities.

Participation pathways across the Club continue to develop. The Men's First Team achieved further success by retaining the Derbyshire County Cup Junior North trophy, while the Women's First Team has continued its excellent progression, securing promotion from the Greater Manchester Women's League Division Three in its first season and positioning itself strongly for further advancement.

Inclusion remains central to the Club's mission. The pan-disability football programme has expanded further with the introduction of a new Under 16 pan-disability team during the season. The Club is particularly proud that one of its young volunteers, Eva McFarlane, was recognised as Derbyshire FA Young Volunteer of the Year, reflecting the Club's commitment to developing young people and providing positive progression routes into coaching, refereeing, volunteering, and employment within the Club.

Alongside this, the Club has just launched a Young Leaders Programme in partnership with the Derbyshire FA, who continue to be a supportive and valued partner. The programme supports young people in developing leadership skills, confidence, and practical experience within a community sports setting, strengthening the Club's long-term sustainability and volunteer pathways.

The Club has also continued to invest in its facilities. Renovation works commenced on Pitch 3 during the year, which will increase weekend football provision for Under 13 and Under 14 age groups, alongside planned improvements to the 9v9 grass pitch and the 3G facility. In addition, the Club is working with the Derbyshire FA on the development of a Social Impact Report, enabling clearer measurement and communication of the wider social value delivered through the Glossop Community Sports Hub.

Fundraising and engagement activity has supported both financial sustainability and community cohesion. Events including a bands and quiz night and a full club photo day were well supported and contributed positively to the life of the Club.

The Trustees and Committee remain committed to strong governance, safeguarding, and long-term sustainability. Regular steering group meetings for the Glossop Community Sports Hub have continued throughout the year, ensuring that the facility remains responsive to community need and is managed in line with the Club's charitable purpose.

I would like to thank our Trustees, Committee members, volunteers, coaches, partners, and supporters for their continued dedication and commitment. The progress achieved during the 2025/26 season demonstrates the strength of the Club and the positive impact it continues to have across Glossop and the wider High Peak. We look forward with confidence to the next stage of our development, both on and off the pitch.

Chairmans Report for 2024/25

We are delighted to have finally opened Glossop Community Sports Hub in April 2024 and welcome our first players to The Ellen White Pitch and open our new club house and pavilion.

This project has been a long time coming but has been welcomed by the club and the community.

We would like to pass our thanks to The Football Foundation, Derbyshire County Council, High Peak Borough council and Derbyshire FA as our principle partners but also the many local companies, people and coaches and players at the club who have helped raise funds and support the new hub. Finally, a huge thanks to the Committee but I am now very excited to see the final project and the impact this will have for not only the Club, but the wider community of the town and surrounding area.

Since opening we have migrated our 45 teams and 600 plus members to training and playing games at Glossop Community Sports Hub from various sites locally whilst continuing to play some games at Newshaw Lane and Melandra Castle, Gamesley which we maintain.

We have also partnered with local club New Mills Juniors as a training facility for some of their teams as well as Glossop Rugby Club and Hayfield Juniors who train at the site. St Philip Howard School also have started using the facility for training and school fixtures and we are very pleased to have partnered with the school.

We also have several recreational sessions such as Just Play Wildcats, Squad Girls, Walking Football, Womens football and Veterans and have a number of local recreational groups taking evening bookings.

We have hosted events for the High Peak Sports Partnership including High Peak finals and SEND events and have hosted a Derbyshire FA Disability tournament with more to come.

The facility has been used by local societies for meetings, and we have held our first coaching CPD events on site.

The club has gone from strength to strength transitioning from a junior club to offering a much wider open age provision. We have introduced a Women's 1st team, an Under 23s team and a Sunday League men's team to broaden our offering. Our first team played in the Derbyshire County Cup Final whilst our under 12 girls won the Manchester FA County Cup, a remarkable achievement for this team.

Our Ability group continues to thrive representing the club in the South Yorkshire disability league and we have seen continued growth in girls' football with a team at every age group, us under 18s Greater Manchester Women's League Cup winners again!

The club continues as a 3-star accredited club and has widened its committee to bring in more experience in Child Welfare, Health and Safety and facilities whilst continuing to focus on developing its football provision.

Finally, we were delighted to host the Football Foundation and several of our supporters at our official opening in September this year where England's all time top goal scorer Ellen White opened the pitch and has had the pitch named after her. We hope the pitch will be a beacon for football and the community in Glossop and The High Peak and we look forward to what the future holds on and off the pitch!

Contracts were awarded to Building Projects Group and McArdles to construct a new clubhouse and 3G Artificial Grass Pitch.

The works are due to complete in January 2024, barring any delays in construction, particularly the weather.

To get to this stage has taken a huge amount of time and effort by the Committee but I am not very excited to see the final project and the impact this will have for not only the Club, but the wider community of the town and surrounding area.

Special thanks must go to our local councillors who have supported this scheme since its inception. High Peak Borough Council and Derbyshire County Council have worked together with the club, our professional team and the contractors to ensure delivery of the project.

Special thanks must go to all those who have contributed towards the costs, especially the above Councils, the Football Foundation and Derbyshire County FA who have assisted us in raising the funds needed to cover the increase in material and labour costs incurred.

The Community Sports Hub will allow the Club to grow its membership by offering more sessions, in particular girls and women's football, pan-disability football, and Veterans Teams.

The Hub is not just for football, and we have engaged with several sporting clubs and associations in Glossopdale, who have expressed interest in using the facility. The benefits of participating in sport are well known and will mean that centres such as Cemetery Road will be critical in not only promoting physical activity for health and well-being but also the mental aspects, by helping people break the habits of inactivity, isolation, and loneliness.

Once complete, with the three pitches at Cemetery Road, a pitch on Newshaw Lane and the site in Gamesley, our members now have the benefit of playing their games on one of five pitches in the town.

Whilst considerable effort has been made to have the Hub constructed, we still have had a football club to run and huge praise in particular must go our Operating Committee and Managers/Coaches to ensure it's been business as usual.

Highlights from the last 12 months include:

- We achieved the maximum England Football 3 star accredited club status
- Gaz Greenall being voted Coach of the Year (Disability Pathway) at the Derbyshire County Football Awards
- The Club being awarded the Lioness Award for all our work promoting girls football in the County
- Our Under 12 Girls team completing a league and cup double
- Our Under 15 and Under 17 Girls teams each winning their Divisional Cup Finals
- One of our Under 18 Girls players being voted Player of the Season in the Greater Manchester Womens Football League
- Our Under 10's Futsal team who became Derbyshire County FA's Champions, along with our Under 18 Futsal team who won the Manchester Futsal League Cup
- Other successes saw several of our younger teams performing in EMJFL, HPJFL and CFGL Cup Finals.

Our core values centre around providing a safe Club, where there is an ethos around diversity and inclusion, zero tolerance to unacceptable behaviour and where people always treat each other with respect. Our success is measured by developing our players, physical, social, technical, and psychological aspects of the game, consistent with FA best practice. We offer consistent coaching, facilities, equipment, and support to all our teams, across all age groups and abilities.

Above all, we act with honesty and integrity.

Grassroots clubs and leagues are built on volunteers. Not one person in this Club receives a salary and all our volunteers (Managers, Coaches, Committee Members, Trustees) contributions are given from their own time, most with full time jobs and families as well.

Again, I want to place on record my thanks to all our volunteers, who make football happen.....without you, it just wouldn't.

Again, to all our members and their families and to all our Sponsors and Grant providers, we really appreciate your continued support and involvement with the Club.

Chairman's Report for the 12 months period: 1st June 2021 to 31st May 2022

Once again, the last 12 months have been another test of the resilience of our volunteers, members, families, but in particular for our Committee.

Whilst we thankfully saw the back of COVID, the implications for the Club were extreme.

Cemetery Road remained the key objective for the Club however the start of 2022 saw a number of issues which delayed the start on site; primarily the cost.

Despite being successful in obtaining additional grant funding from The Football Foundation in July 2021, COVID, together with an increase in labour and material costs as a result of inflation, has seen the budget for the scheme rise from £1.8m to £2.4m in January 2022. The Club's Committee has been in constant negotiations and discussions with our building contractors and funding partners to see how this cost can be bridged.

There remains a willingness from all parties to deliver a scheme, so we remain confident that additional funds will be forthcoming to allow work to begin by September 2022. The Community Sports Hub will allow the Club to grow its membership by offering more sessions, in particular girls and women's football, pan-disability football, and Veterans Teams.

The Hub is not just for football, and we have engaged with several sporting clubs and associations in Glossopdale, who have expressed interest in using the facility. The benefits of participating in sport are well known and coming out of COVID, will mean that centres such as Cemetery Road will be critical in not only promoting physical activity for health and well-being but also the mental aspects, by helping people break the habits of inactivity, isolation, and loneliness.

Aside from Cemetery Road, we have continued our investment into the grass pitch at Melandra Castle, Gamesley. Unused for about 18 months,

the pitch and surrounding area was over-grown and had seen vandalism of the perimeter fencing, goal-posts, changing rooms and toilet block. With funding from Club resources and Football Foundation, we were able to bring the site back into use, not only for our older age-group teams, but in partnership with Glossop Wasps, another community-run football club based in the town.

With the three pitches at Cemetery Road, a pitch on Newshaw Lane and the site in Gamesley, our members now have the benefit of playing their games on one of five grass pitches in the town.

Whilst we are a not 'a win at all costs' club, we have had some notable positive outcomes on the pitch this year, with our Under 21's winning the Manchester FA Sunday Amateur Cup and also securing promotion in their league. In addition our Under 15 Blues won the EMJFL Challenge Cup as well as winning promotion. Our Under 13 Girls made it through to the final of the Manchester FA County Cup but unfortunately lost out to an excellent Irlam JFC team. Other successes saw several of our younger teams performing in EMJFL, HPJFL and CFGFL Cup Finals.

Our core values centre around providing a safe Club, where there is an ethos around diversity and inclusion, zero tolerance to unacceptable behaviour and where people always treat each other with respect. Our success is measured by developing our players, physical, social, technical, and psychological aspects of the game, consistent with FA best practice. We offer consistent coaching, facilities, equipment, and support to all our teams, across all age groups and abilities.

Above all, we act with honesty and integrity.

Grassroots clubs and leagues are built on volunteers. Not one person in this Club receives a salary and all our volunteers (Managers, Coaches, Committee Members, Trustees) contributions are given from their own time, most with full time jobs and families as well. Again, I want to place on record my thanks to all our volunteers, who make football happen.....without you, it just wouldn't.

Again, to all our members and their families and to all our Sponsors and Grant providers, we really appreciate your continued support and involvement with the Club.

The object of the charity is to promote community participation in healthy recreation by providing facilities for playing association football (facilities means land, buildings, equipment and organising football activities).

OBJECTIVES AND ACTIVITIES

Significant activities

The last 12 months have been another test of the resilience of our volunteers, members, and families.

COVID has once again decimated the training and playing season for many of our members and volunteers. No football had been played since the outbreak in March 2020 and the impact on our members' and volunteers' welfare was clear. Financially the lock-down was also having a negative impact on our member's parents, with many being furloughed from work or made redundant. Having benefitted from a Sport England Community Emergency Fund Grant, this led to the Club offering to suspend the collection of subscriptions for a 5-month period, with around no. 125 of our members parents taking up the option, at the time.

With the planned return to football in July 2020, there was much positivity within the Club, despite the numerous protocols which we all needed to follow. The Club set up a Working Party around these new procedures in order to operate safely, so huge thanks to the Team, which allowed the season to begin on-time in September 2020 with 38 teams and over 520 members playing regularly.

Instances of the Delta variant of COVID then began to increase and in December 2020 under instruction from the Government and the FA, all football stopped again as part of a country-wide lock down, for an initial 4-week period. Matters unfortunately didn't improve in Derbyshire, which only led to the resumption of training and playing in March 2021. In all, over the 12-month period to May 2021, we lost approximately 6 months of playing time.

As a Club and Committee though, we were not idle during this time.

Cemetery Road remained the key objective for the Club for 2020/2021.

The Community Sports Hub will allow the Club to grow its membership by offering more sessions, in particular girls and women's football, pan-disability football, and Veterans Teams.

The Hub is not just for football, and we have engaged with several sporting clubs and associations in Glossopdale, who have expressed interest in using the facility. The benefits of participating in sport are well known and coming out of COVID, will mean that centres such as Cemetery Road will be critical in not only promoting physical activity for health and well-being but also the mental aspects, by helping people break the habits of inactivity, isolation, and loneliness.

Several of the Agencies involved continued to have furloughed staff during this period however, which delayed matters significantly, but were outside our control. The tender exercise which was due to be undertaken in March 2020 was postponed until November 2020, with a resultant cost increase in the scheme.

The Club continued to work closely with the Football Foundation, the County FA, Derbyshire County Council and High Peak Borough Council during the Year. Our pre-commencement planning discharge application has been submitted and is awaiting approval.

January 2021 saw the launch of our Crowdfunder campaign for the Hub. We launched with a video 'Help Give Football a Home', which galvanised the Club, its volunteers, and members to raise the additional funds needed. Numerous events took place including:

Virtual Pie & Pint - Raffle - Virtual Wine Tasting Event - 24-hour Gaming stream - Auction - Climb the Burj Khalifa - dribbling challenge where a team covered 184 miles in 40 days - Cycling challenges - Running a half marathon - Cake Making - Running to Wembley (equivalent) - Running up Glossop Nab - Family Quiz Night - Litter Picking Challenge.

In total over 3 months, the Club and our members were able to raise an additional £50,000 towards the cost of the Centre. Of this amount £32,116 is included in the accounts at 31 May 2021 (the additional amount raised after 31 May 2021).

The aim is now to submit a revised Funding Application to Football Foundation in July 2021 of £1.230m, which alongside funding from High Peak Borough Council, the Club's contribution and other grant providers including Sport England, should mean sufficient funds are in place for the Centre to be built, with works commencing late 2021/early 2022.

Aside from Cemetery Road, we completed on an agreement to use the grass pitch at Melandra Castle, Gamesley. Unused for about 18 months, the pitch and surrounding area was over-grown and had seen vandalism of the perimeter fencing, goal-posts, changing rooms and toilet block. With funding from Club resources and Football Foundation, we were able to bring the site back into use, not only for our older age-group teams, but in partnership with Glossop Wasps, another community-run football club based in the town.

With three pitches at Cemetery Road, a pitch on Newshaw Lane and the new site in Gamesley, our members now have the benefit of playing their games on one of five grass pitches in the town.

We are a huge advocate of the female game and in June 2020 we supported the FA in its launch of the 'Game Plan for Growth' which is inspiring positive change in creating a sustainable future for women's and girls' football in England. At that time, we had - 8 all-female teams - 2 years' experience of running the 5-12-year-old 'Wildcats' sessions - a Ladies Recreational Team and 100 female members. The 5-year plan outlined the aspiration by June 2025, of doubling these participation numbers - as a Club we have also committed to increase the number of women and girls playing football with us, in line with this target.

OBJECTIVES AND ACTIVITIES

Ryan Williams - awarded the Rising Star of the Year Award from Derbyshire County Football Association for his work at the Club with our Futsal offering. Ryan is 21 years of age and challenges the players to improve week on week, offering inclusive sessions for a wide range of players, of differing abilities.

In December, the Club organised a food collection for Glossopdale Foodbank. In all we were able to deliver 28 hampers of food and presents to the organisation, for distribution to families in need, around Glossop.

Our success on and off the pitch is not measured by trophies.

Our core values centre around providing a safe Club, where there is an ethos around diversity and inclusion, zero tolerance to unacceptable behaviour and where people always treat each other with respect. Our success is measured by developing our players, physical, social, technical, and psychological aspects of the game, consistent with FA best practice. We offer consistent coaching, facilities, equipment, and support to all our teams, across all age groups and abilities.

Above all, we act with honesty and integrity.

Grassroots clubs and leagues are built on volunteers. Not one person in this Club receives a salary and all our volunteers (Managers, Coaches, Committee Members, Trustees) contributions are given from their own time, most with full time jobs and families as well. Again, I want to place on record my huge gratitude to them all, who have had such difficult circumstances to deal with again this year. Their enthusiasm remains infectious, they continue to deliver a community organisation that has the best and safest training and coaching environment possible, and I am proud that they are associated with this Club.

Again, to all our members and their families and to all our Sponsors and Grant providers, we really appreciate your continued support and involvement with the Club.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

Going Concern
