We are a small church that holds meetings every Sabbath (Saturday) that are open to the public during which we have teachings, fellowship, prayer, and a meal. We have a wider audience for our teachings online of people who live too far away to attend our church every week and thus we work to provide good quality videos of our teachings for our online audience.

When planning our activities for the year our trustees have considered the Commission's guidance on public benefit and in particular the specific guidance regarding charities for the advancement of religion. We seek to teach people about the Scriptures and how to live out their lives in accordance with it, as well as offering pastoral care, and hosting the celebration of the feasts found in the Scriptures. The trustees have also considered the Commission's guidance specifically regarding the relief of poverty in that we have also provided some financial relief to the poor who were unable to meet their basic needs.

Summary of the main achievements of the charity during the year

This year we held our regular meetings every sabbath (Saturday) wherein we teach the Scriptures, pray, share a meal and fellowship and offer pastoral care. We provided financial assistance to some to enable them to come to our sabbath meetings. We also have a number of people who consider themselves part of our congregation but they are unable to attend because they live far away. We have been able to livestream our weekly meetings online as well as post midweek videos and videos on the Biblical feast days to provide people with teaching and a sense of community even when they could not meet in person.

We hosted the celebrations of the Biblical feasts this year (i.e., Passover, Pentecost, the Feast of Trumpets, Yom Kippur, and the Feast of Tabernacles). We hosted a celebration of the Feast of Tabernacles for congregants in the US who follow our teachings and consider themselves part of the fellowship, but who live too far away to attend our weekly meetings. We were able to assist some financially with the ability to travel to and keep these Biblical feast days and to pay for some group meals for these celebrations.

We have also been able to aid in the relief of poverty by offering some relief to those facing financial hardship including members of our church who were unable to meet their basic needs and struggling to pay their bills, afford petrol money, and to move house.
