Activities: We make grants to benefit young people (aged 11 to 20) who are in need of of financial assistance in their education. The beneficiaries must be those who may attend, are attending or have attended a School in the borough of Chesterfield (excluding Staveley). The awards are normally made via the School, College or other educational establishment involved.We also preserve artefacts and documents
