The trustees of PUSHTINIKUNJ FOUNDATION present their report along with the financial statements of the charity for the year ended 30 April 2025 which comprise of the Statement of Financial Activities and the Balance Sheet. Constitution and Objects

Pushtinikunj Foundation is a private limited company and is a registered charity number 1179674.

The object of the charity is to further the education and training of children, assist in relief of poverty, provide overseas aid/ famine relief and assist in promoting Hindu Religion.

Organisation

The trustees who have served during the period and since the period end are set out on page 2.

Trustees are appointed by the board of trustees and serve for 5 years after which period they may put themselves forward to re-appointment.

Trustees' Responsibilities in Relation to the Financial Statements
