Our total financial income for 2020-21 was £25,879 compared to £28,522 the previous year. Our expenditure for the year 2020-21 was £20,732 compared to £29,689 the previous year. Our current balance was £11,569 compared to £6,422 the previous year.</p> <p>Our donors were relatively constant from the previous year but our expenditure in the current year under review was less due to the fact that there were no hall hiring and musician hiring changes incurred.</p>

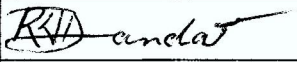

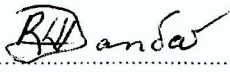
