Activities: Promoting the study of Theology and Philosophy between members, especially former students and staff of Heythrop College, University of London, and in the wider world, by arranging seminars, study days, social opportunities, and other events so that members can hear, exchange, debate, and appreciate the ideas of others in the disciplines of Theology and Philosophy for the public benefit.
