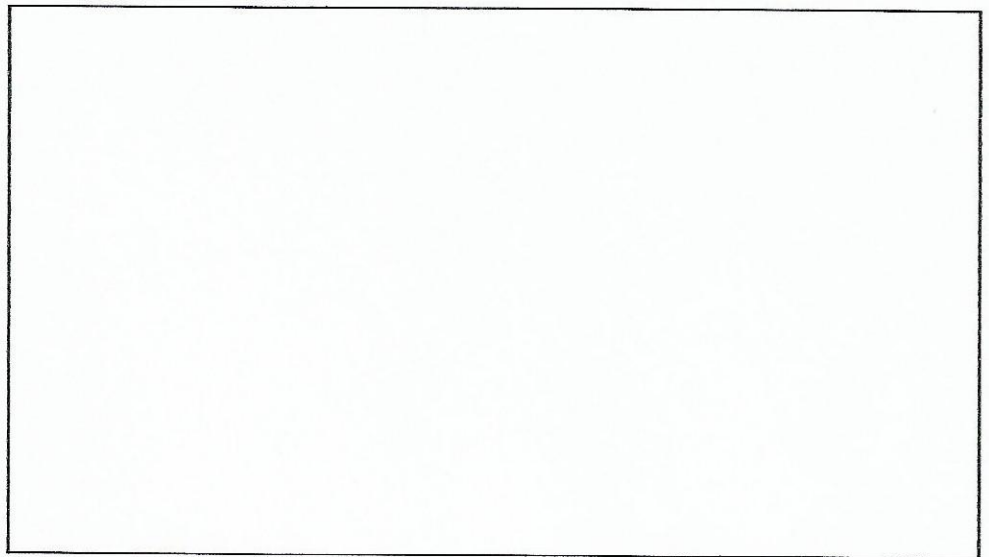

THE OBJECTS OF THE CIO TO BE CARRIED OUT IN AN AREA OF A RADIUS OF 15 MILES OF THE TOWN OF BANBURY IN OXFORDSHIRE, HEREINAFTER REFERRED TO AS THE "AREA OF BENEFIT", ARE:

3.1 FOR THE PUBLIC BENEFIT TO ADVANCE THE EDUCATION AND DEVELOPMENT OF CHILDREN IN PARTICULAR BY PROVIDING CHILD CARE AND NURSERY/EARLY YEARS EDUCATION WHICH WILL:

3.1.1 PROMOTE THE CARE AND SAFETY OF CHILDREN;

3.1.2 PROMOTE THE HEALTH AND WELLBEING OF CHILDREN;

3.1.3 PROMOTE PARENTAL INVOLVEMENT; AND

3.1.4 PROVIDE SERVICES TO SUPPORT CHILDREN AND THEIR FAMILIES/CARERS.

3.2 TO ADVANCE EDUCATION AND PROTECT AND PRESERVE GOOD HEALTH AND WELLBEING AMONG CHILDREN AND THEIR FAMILIES/CARERS BY PROVIDING GRANTS OF FINANCIAL ASSISTANCE TO CHARITIES AND VOLUNTARY ORGANISATIONS WITHIN THE AREA OF BENEFIT WHO ARE ESTABLISHED FOR THESE PURPOSES INCLUDING, BUT NOT LIMITED TO, SUNSHINE CENTRE CONNECTING COMMUNITIES.


