## **Structure, governance and management**

### **Governing document**

Scene Change Productions is a charitable incorporated organisation governed by its Constitution dated 17 January 2018. The only voting members are its trustees.

If the CIO is wound up, the members of the CIO have no liability to contribute to its assets and no personal responsibility for settling its debts and liabilities.

### **Appointment of trustees**

Every trustee must be appointed for a term of three years by a resolution passed at a properly convened meeting of the charity trustees. In selecting individuals for appointment as charity trustees, the charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

### **Organisation**

Since Scene Change Productions was conceived in January 2018, the Trustees have met on nine occasions with constant email and telephone contact in between meetings. The Trustees intend to meet on a monthly basis now that fundraising and meeting its' charitable objectives have commenced in earnest.
