Providing the surrendering owners with support and guidance, often in difficult circumstances and at short notice, We have supported individuals with equipment and necessities on an ad hoc month by month basis to ensure that both the owners and their dogs are safe and well cared for. We have sent equipment, food, and necessary essential equipment to rescues in the UK, Romania, Bosnia, Macedonia, Croatia Ukraine and Cyprus on a regular basis. Supporting community endeavours / projects through post COVID-19 Pandemic/ financial crisis to give aid to Elderly pet owners peace of mind in difficult times. Supporting those in need as and where we can, funds, supplies and equipment have been available. We have worked with other Charities /rescues/ breed specific organisations within the UK with surrenders out of area, utilising a growing network of foster homes, both short and long term. We have continued to provide long term (till end of life) homes for 5 elderly dogs who would have normally been put to sleep, and now have warm safe comfortable homes for life.</p>
