**TRUSTEES' REPORT**

**For the year ended 31 March 2022**

---

The Trustees submit their annual report and the financial statements of Abbey People CIO for the year ended 31 March 2022. The Trustees have adopted the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" (FRS 102) in preparing the annual report and financial statements of the charity.

The financial statements have been prepared in accordance with the accounting policies set out in the notes to the financial statements and comply with the charity's governing document, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published in October 2019.

**Objects**

To promote for the benefit of the inhabitants of Abbey Ward in Cambridge the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving the condition of life of the said inhabitants.

**Structure, governance and management**

Abbey People CIO was formed by a governing document dated 10th May 2018 and was registered as a charity on 5th November 2018.

The Trustees who served during the year and are serving currently are shown on page 1.

New Trustees are recruited to support the objects of the Charity, by resolution of the Trustees as laid down in the Constitution.

The Board oversees the Charity's management and operation, with the Operations Committee having oversight of the delivery of our wide range of support to the local community. We are also fortunate in having a very engaged and dynamic staff team.

**Review of activities and achievements**

We have had a busy and successful year, despite the challenges of COVID and a cost-of-living crisis. We've directly helped over 500 people and have had over 100 people volunteer across our projects. This year saw our 'core' activities and groups return after the pandemic 'lockdowns'. As well as this, we have continued to deliver and develop our 'Covid Response', including the Food Hub and establishing the 'Helping Each Other' threads of our work.

We were really pleased to be able to return to hosting community events this year. We hosted a massive six events through our Little Free Libraries project (funded by the Cambridgeshire County Council Talking Together programme), our Summer Family event, a half-term Holiday Hunger event in partnership with Cambridge United Community Trust, The Abbey 'Late' Big Lunch, and a Winter Festival. As these events all took place within six months, we were really busy!

The Food Hub moved into the 'youth building' on the community centre site in May 2021, after a year at Barnwell Baptist Church. We'd like to thank the church for hosting the first year of the Food Hub, and for their ongoing support of the project.

The community centre itself started to become busy again over the course of the year, as groups started to return. We also saw an increase in the number of family gatherings and birthday party bookings. It is good to be able to provide such an important gathering space to the community, especially after the difficult few years we have had.

This year was the first year in our three-years of funding from the Westminster Foundation for youth work provision, which has allowed us to expand our general work with young people, as well as bringing the first young people into our Coffee Truck project: Barnwell Baristas. The Coffee Truck has proved popular at some local events as well, and we expect external bookings to increase in 22-23. Our general youth work provision includes our Junior Youth Club, Girls Group, Coding Club (funded by Amazon in the Community) and the Holidays Activities and Food provision, in partnership with Cambridge United Community Trust and Funded by the Department for Education via Cambridgeshire County Council.

We've had exciting new developments in our Greenspaces work, with funding from the Cambridge Water Pebble Fund for a new project with Cambridgeshire County Council, Keeping Britain Tidy's Rivercare programme and CAMEO (Anglian Water) to carry out much needed conservation work on Coldham's Brook. We've also been working with The Library Presents, Teasels Biodiverse Design and Hurdy Gurdy Glass on Barnwell Verge: Seeds of Hope – a project to improve the verge along Barnwell Road. Our Green Team also continues to be busy with the Margaret Wright Community Orchard and Community Allotment, which grew enough to bring surplus to the Food Hub as well!

Volunteers have been a key part of what we have done since we were first founded, and this is truer than ever this year. We could never do the amount of work we do for the community without the commitment of the many volunteers who are involved. The trustees cannot thank them enough! We've had more than 100 people involved as volunteers across the organisation, with more than 2,000 volunteer hours. Part of our work this year has been to agree a new volunteer agreement and develop new processes to make it easier for people to sign up to volunteer and get going in roles and tasks. We continue to have regular interest from new volunteers and look forward to meeting anyone interested in volunteering in our community

At our AGM in November 2021, Stuart Wood stepped down as trustee and Chair, after more than nine years involved with the organisation. As one of our founders, Stuart has been a key part of the organisation and the trustees would like to take the opportunity to thank him for all his hard work and energy over the years. We will continue to work closely with him in his other roles within the community in the future.

James Pilgrim, previously Chair of the Operations Group was elected chair in November 2021, with Jo Bromwich moving into the Treasurer Role. Lynsey Stafford was elected Chair of the Operations Group. Peter Gotham and Sharon Secker remain in their officer roles. We were pleased to welcome Mike Kovacs to the Board in this year.

Fundraising has been a key priority for the year, with the Friends of Abbey People programme launch. We've been overwhelmed by the support both from within the Abbey Community and across the country. The team have also launched the 10 for 10: for Cambridge campaign, as a way to reach companies that would like to support our work. There has been very good early interest and we'd like to thank Marshall and AVEVA for being the first of our 10!

The charity has had another strong performance financially, with great success in fundraising from grant organisations, as well as a good first year of regular giving. We've also had support from corporate giving, including Marshall, Pennington Manches, and Grosvenor as well as AVEVA, who were a new supporter this year.

One of the highlights of this year has been agreeing a new charity strategy and three-year vision for 2022- 2025: Building Strong. As we start to move toward a post-pandemic world, we are in an exciting position to be able to bring an innovative strategic vision for the community to build strong foundations for future growth. Including: creative delivery of community engagement activities, strengthening partnerships to maximize impact for the area, all while working with our beneficiaries and stakeholders to create a vibrant, resilient community for the future.

In all the work we do, we focus on creating opportunity for community engagement and volunteering, knowing that all our work is improved by having volunteers and beneficiaries involved in the delivery. Our work helps the people living in our area have agency over their community and lives. The following work areas will be the focus of the charity's work over the time of this strategy.

**Vibrant community**  
**Helping each other**  
**Supporting the next generation**  
**Sustainable environment**

We aim to do this by walking alongside people as neighbours, getting to know people, creating volunteering opportunities and working in partnership.

Our work since April 2022 has focused on delivering projects within this strategy: with exciting new developments in the Coffee Truck project – which sees the coffee truck at the Cambridge United Home games in the 22-23 season; work toward making the Food Hub more resilient and setting up a sustainable model for the future; new partnership working across the NHS Integrated Care Service and with Kings Hedges Family Support Project to support families in Abbey; and more exciting biodiversity and greenspaces projects to come at well.

The Trustees would like to thank our grant funders, donors, corporate donors and partners for their ongoing support.

### **Public benefit**

When planning our activities for the year, the Trustees have considered the Charity Commission's guidance on public benefit.

### **Financial review**

As noted above the charity has changed significantly in the year, with more varied income supporting a greater range of work, and enabling us to recruit much-needed staff. Covid continued to be a challenge, and we are very grateful for the support of the community as well as for the statutory funding we have received. The accounts reflect the increasing range of income and activity.

The reserves at the year-end separate the designated Community Centre and fixed asset funds of £77,540 from the "free reserves". Although these have increased from £15,036 to £35,315, this is still short of our target of 3 month's operating costs. This is £51,000 - based on the 2022/23 budget.

At the year-end the charity also had forward funding balances in the restricted fund of £40,788 (2021 £39,966).

**Statement of Trustees' responsibilities**

They are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Charities Act 1993. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the detection and prevention of fraud and other irregularities.

**Independent examiner**

The Charity's independent examiner, Geoff Mann FCIE, has indicated his willingness to continue in office and offers himself for re-appointment.

As the charity's trustees you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').





## NOTES TO THE FINANCIAL STATEMENTS

For the year ended 31 March 2022

---

### 1. ACCOUNTING POLICIES

#### **a. General information and basis of preparation of financial statements**

Abbey People CIO is a charitable incorporated association, established in the United Kingdom. The nature of the charity's operations and principal activities are described in the Trustees' report.

The charity constitutes a public benefit entity as defined by the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102). The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) published in October 2019 (SORP 2019), FRS 102, the Charities Act 2011, and UK Generally Accepted Practice as it applies from 1 January 2019.

The financial statements are prepared on a going concern basis under the historical cost convention, modified to include certain items at fair value.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented unless otherwise stated.

#### **b. Fund accounting**

Unrestricted funds which have not been designated for other purposes are available for use at the discretion of the trustees in furtherance of the general objectives of the charity.

#### **c. Income recognition**

All incoming resources are included in the Statement of Financial Activities (SoFA) when the charity is legally entitled to the income after any performance conditions have been met, the amount can be measured reliably and it is probable that the income will be received.

For donations to be recognised the charity will have been notified of the amounts and the settlement date in writing. If there are conditions attached to the donation and this requires a level of performance before entitlement can be obtained then income is deferred until those conditions are fully met or the fulfilment of those conditions is within the control of the charity and it is probable that they will be met. Gift Aid receivable is included in income when there is a valid declaration from the donor. Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.

No amount is included in the financial statements for volunteer time in line with the SORP 2016. Further detail is given in the Trustees' Annual Report.

#### **Expenditure recognition**

#### **d.**

All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Expenditure is recognised where there is a legal or constructive obligation to make payments to third parties, it is probable that the settlement will be required and the amount of the obligation can be measured reliably.

#### **e. Tangible fixed assets**

Tangible fixed assets are stated at cost (or deemed cost) or valuation less accumulated depreciation and accumulated impairment losses. Cost includes costs directly attributable to making the asset capable of operating as intended.

## NOTES TO THE FINANCIAL STATEMENTS

For the year ended 31 March 2022

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost, less estimated residual value, of each asset on a systematic basis over its expected useful life as follows:

- Computers and IT - 3 years
- Office and Other Equipment - 3-5 years
- Vehicles - 4 years

**f. Investments**

Investments are recognised initially at fair value which is normally the transaction price excluding transaction costs. Subsequently, they are measured at fair value with changes recognised in 'net gains/(losses) on investments' in the SoFA if the shares are publicly traded or their fair value can otherwise be measured reliably.

**g. Debtors and creditors receivable / payable within one year**

Debtors and creditors with no stated interest rate and receivable or payable within one year are recorded at transaction price. Any losses arising from impairment are recognised in expenditure.

**h. Going concern**

The financial statements have been prepared on a going concern basis. The trustees set a minimum reserves policy designed to ensure the charity can meet all obligations as they fall due, and have sufficient time to respond to any reductions in income to allow costs to be reduced and continue as a going concern.

**i. Judgements and key sources of estimation uncertainty**

The Trustees do not believe that any significant judgements or estimates have been needed in compiling these financial statements






