### TRUSTEES ANNUAL REPORT 2022/23

**We are part of the Lions Club International and at present we have 20 members.**

**Our purpose is to raise funds to help with local charities and activities in our area.**

**Most of the income has been generated by Father Xmas and his sleigh which we take out most nights in December, we drive around local streets agreed by the police and members and volunteers collect money in buckets which is counted and banked the next day. We managed to raise £11,678. and with the balance carried forward total expenditure for the year was £17341.23 One of the charities helped was 'Helping Hands' who we contributed £4400 towards purchasing a van so that they could deliver food parcels to those who needed them due to Covid restrictions which were gladly received by people in need.**
