- A local humanitarian endeavour delivering aid to Ukraine and operating under the title Cornwall and Devon Sending Love to Ukraine was supported by Callington Lions. Other Lions clubs, individuals and other organisations in the area also supported this endeavour, passing funds to Callington Lions where they were forwarded onto Cornwall and Devon Sending Love to Ukraine. In total we received £6,836 in the year (£17,893 – 2023) which was passed on. This has inflated our income and donations made.

## Achievements and Performance

The trust move the date of the town's Honey Fair to a Saturday for the first time and this, together with closer engagement with other organisations in the community, helped to increase public attendance by 36%. We have also run other community events such as Bingo and supported several community events such as Remembrance Day, Father Christmas, Civic Service, May Day etc.


### Independent examiner's statement

## Achievements and Performance




