CURRENTLY, THE MONEY RAISED IS DONATED TO UK REGISTERED CHARITIES WHICH WORK FOR THE EDUCATION OF DISADVANTAGED CHILDREN IN THE UK OR ABROAD. IN DOING SO, THE TRUSTEES CONSIDERED EDMUK'S OBJECTS AND THE CHARITY COMMISSION PUBLIC BENEFIT GUIDANCE.

THE ACCOUNTS OF THE CHARITY FOR THE YEAR ENDED 31 AUGUST 2024 SHOW TOTAL RECEIPTS (FROM TRADING) OF £7,330.

THE CHARITY'S ONLY EXPENSES ARE ITS INSURANCE AND ITS WEBSITE. THERE ARE NO EMPLOYEES, ONLY VOLUNTEERS. THIS MEANS THAT CURRENTLY 98% OF THE MONEY RAISED FROM OUR ACTIVITIES ARE DONATED TO UK CHARITIES.

THE CHARITY DONATED £2,000 TO GIVE A BOOK, £2,000 TO MAGIC BREAKFAST AND £2,500 TO ZARACH IN THE YEAR TO 31 AUGUST 2024.

THE TRUSTEES AIM FOR CLUB RANDO TO CONTINUE TO RAISE AN INCOME OF APPROX. £7,000 TO £8,000 ANNUALLY.
