### Summary of the objects of the charity set out in its governing document

The object of the CIO is the promotion of social inclusion amongst those who are socially excluded from society, or parts of society, as a result of a disability or learning difficulty through the provision of, but not limited to: A) advice and support to families affected by autism spectrum condition to eliminate the stigma associated with autism and the barriers within society; and B) raising public awareness of autism by sharing knowledge and working with the local community and local organisations such as schools etc to educate and encourage collaboration of social and recreational facilities and events involving the local community.

**Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)**

The charity's activities for this period involved engaging with members of the public on social media channels and the charity's website, engaging with local businesses and creating outreach materials. The trustees have had regard to guidance issued by the Charity Commission on public benefit and as such have undertaken all activities in relation to the objects for the benefit of the public.

For object A, we have continued to expand our social media influence and outreach with autistic people and their families as well as members of the general public. Although not solely for Bristol, the channels centre around local communities in Bristol, providing more localised and relevant platforms compared to larger charities that are based nationally. This allowed the charity to engage directly with service users to provide and receive feedback on the challenges autistic people face in their daily lives due to stigma and barriers within society. We also successfully created platforms to share polls and stories of success and achievements, raise awareness and share links and resources. Likewise, we have shared the research questionnaire with a wider audience and created a short poll based on the questionnaire to make it more accessible. We have used data from the questionnaire to inform our outreach to local businesses on what they can do to make their premises more accessible and inclusive.

For object B, all of our activities have been undertaken for raising awareness of autism for the public benefit. We developed social media and the website as ways to engage with the public and share information with them, to educate and encourage local communities on what inclusivity looks like for autistic people and their families. Our media channels also benefitted service users and the public in keeping them updated on our campaigns for raising awareness in Bristol specifically and on our collaborations with local businesses. We have approached numerous cafes and supermarkets around Bristol with a successful campaign event hosted at Tesco.

Our main achievements include those from our activities above as well as admin and financial management.

1. We have achieved a strong social media presence with progressively increased engagement on Instagram, Facebook and Twitter. This achievement successfully set the foundation for public engagement and awareness-raising campaigns this year and going forward.

2. Approached cafes and supermarkets in Bristol, providing them with informational leaflets and details about our campaign for businesses. Tesco agreed to host an event, and we engaged with customers and provided them with information about autism.

3. Commissioned a charity banner, training pack and custom t-shirts for our campaign for businesses. Printed and distributed informational leaflets for the general public.

The trustees have had regard to guidance issued by the Charity Commission on public benefit and as such have undertaken all activities in relation to the objects for the benefit of the public.

For object A, we developed social media channels with autistic people and their families in mind to provide a platform for sharing advice, support and inspiration. These would allow the charity to engage directly with service users to provide and receive feedback on the challenges autistic people face in their daily lives due to stigma and barriers within society but also share stories of success and achievement. Although not solely for Bristol, the channels do centre around local communities in Bristol, providing more localised and relevant platforms compared to larger charities that are based nationally. Likewise, we developed the research questionnaire to conduct a priority needs analysis of the Bristol area and collect up-to-date data from autistic individuals and/or their families for reducing barriers to social inclusion.

For object B, most of our activities have been undertaken for raising awareness of autism for the public benefit. We developed social media and the website as ways to engage with the public and share information with them, to educate and encourage local communities on what inclusivity looks like for autistic people and their families. Our media channels would also benefit service users and the public in keeping them updated on our campaigns for raising awareness in Bristol specifically and on our collaborations with local businesses. Developing the promotional video contributed directly to providing information about our campaign for businesses by giving the public a concrete example of what an autism-friendly business could look like and its potential impact for autistic people. Also for the public benefit and in response to public feedback, we updated our logo from its original puzzle-piece heart shape as the puzzle piece is associated with stigma and incorrect understandings about autism.

## Achievements and performance

### Summary of the main achievements of the charity during the year

Our main achievements include those from our activities above as well as admin and financial management.

1. We have achieved a strong social media presence with regular engagement by our social media manager on Instagram, Facebook and Twitter. This achievement is crucial and sets a foundation for public engagement and awareness-raising campaigns going forward.
2. In collaboration with a website designer and the trustees, we have also completed the design of our charity's website and a promotional video that demonstrates one of our key campaigns and what it would look like in action. The website is also key to keeping the public informed about our activities with local businesses, schools and public services in Bristol.
3. Through ongoing collaboration with trustees, a logo designer and members of the public, we now have a uniquely-designed logo that positively reflects the aims of our charity and the people our charity serves.
4. We created a research questionnaire and have already begun receiving responses to it that have allowed us to establish priority areas of concern and feed those concerns forward into our campaigns.
5. A significant achievement was the streamlining of policies, procedures and management of accounts and charity administration. We set up a financial management system and annual review process that is efficient, highly transparent and compliant with statutory and non-statutory guidance from the Charity Commission. We created a system for records keeping of financial statements, invoices and expense claims as well as forms and policies for claiming expenses. We made our meetings of the trustees more efficient through setting regular agenda items, standardising the recording/reviewing of minutes and establishing a policy on disclosing conflicts of interest in line with Charity Commission guidance and rules. Finally, we established procedures for reviewing these systems annually so that we can continue to maintain and improve upon them going forward.

For this financial period, the charity had a 'zero level' reserves policy. This is because we had received our first non-renewable grant at the end of the previous reporting period, which would be used for setting up operations throughout the year. The charity had no other source of income. The trustees also determined that there were no risks of unforeseen emergencies or unforeseen operational costs that would require funds as these were not applicable.

The principal source of funding was a grant received at the end of the previous reporting period, which was carried over to the current period. Expenditure has supported both objects, through the hiring of a social media manager and designers for the website, logo and promotional video to establish the charity's online presence and begin reaching out to the public. Through our social media manager, the charity engaged with families and individuals, reached out with a questionnaire to gather data about priority needs in Bristol and promoted autism awareness for public benefit. These channels provided a platform for two-way communication between the charity and service users to provide information on the charity's objectives and campaigns and to receive direct feedback on these, all for public benefit. The website and promotional video had also been completely designed by the end of this reporting period and would be launched the following period to directly support the key objects. Trustees had also volunteered a great deal of their time to keep costs down and stretch our funding for establishing the campaigns.

2. Matters Arising: Warm welcome to Kate Williams, our part-time social media manager, and Jahantab Hasmi, a newly appointed Trustee. Also thank you to Nisba Ahmed, who has been working on our behalf on campaigns and has officially been appointed as a charity Trustee. 1. Welcome and review from previous meeting
2. Matters Arising: All matters arising should include any actions set during the previous meeting. For example, the matters arising for our next meeting of the trustees should address any actions set during this meeting (15<sup>th</sup> June 2023). Trustees have also proposed including an action log with time scales and who reviews them at each meeting. Each meeting agenda should include a moment for all the trustees to review previous meeting minutes to check for accuracy.
3. Funding update: Nisba has submitted two funding bids to the Council, who are still in process of making decisions. They have been provided with up-to-date financial accounts for the charity. It was noted by one of the funding agencies that they look for charities who have been established for a number of years to see if they can manage accounts accurately.
4. Campaigns update: the scooter project is still on but will need a lot more organising with council and sponsorship. Trustees have also suggested getting in touch with schools (SENDSCO) to distribute questionnaires to parents/carers.
5. Website & Media: website content has been updated, and we are aiming to go live soon. Trustees will be updated as soon as we do. In the meantime, there are empty slots on the website that need to have content in them when it goes live. Tammy will write a post with an update on our campaigns. The website also needs to include a

link to the questionnaire. The promotional video is complete, and all the trustees present were able to watch. Feedback has been positive. Kate informs us that we are live on Instagram, Facebook and Twitter. She recommends sharing and commenting on posts, as that will boost traction. Instagram currently has 355 followers, up from 200 last month. Facebook needs to be more sociable to attract more followers. Pictures of trustees working on a campaign event in charity t-shirts would boost the charity's presence. Tammy informs us that JumpStory is offering a good rate for an image subscription. Everyone has noted that the images are of very high quality, but that we should not go ahead with a subscription at this time.

6. Finances: No concerns or issues have been raised. The 2021-22 annual return was submitted on time on 2<sup>nd</sup> May 2023. The 2022-23 annual return will be due around the same time next year, and a forthcoming date for review will be set closer to that time.
7. Admin: the business letter needs updating and printed so that Kate has something to give businesses managers when she approaches them. She is otherwise ready to go out to businesses to introduce the charity and find out which businesses are interested in our campaign. T-shirts are ready to be printed, and Tammy will inform the company that we are happy to proceed with the order. Leaflets will also need to be printed soon, and possibly lanyards, as well.
8. Actions to complete by next meeting: Tammy will place the order for t-shirts and a standup poster for our campaigns, which has already been designed. She will update the business letter and print a set for Kate and will also create a post for the website. Kate will go around to businesses to attract interest in our campaign for businesses. She will also post polls on Instagram. Naveeda will look into getting a pack/presentation professionally designed to be ready for our campaign for businesses.
