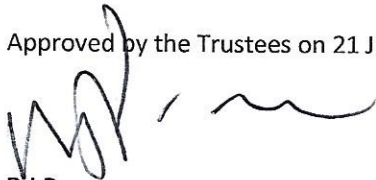

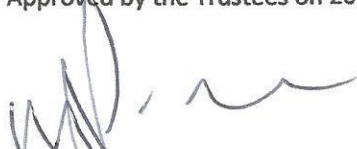
The Trustees' policy is to build up a single cash fund, to be drawn on in the event of an appropriate injury being notified to them, which is fortunately an infrequent event.
