Basis of opinion

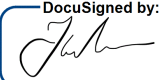

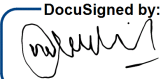

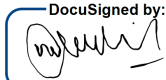
For the year ending 31st January 2025 the company was entitled to exemption from audit under section 477 (2) of the Companies Act 2006.

1 ACCOUNTING POLICIES

1.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS
