1. Mission Statement

Rationale Arts is a registered charitable arts organisation with the key aims to promote, improve, and maintain public education and appreciation of the arts. Specifically, but not exclusively the art of dance, music, and theatre.

We aim to achieve our mission mainly through 4 avenues.

- **Community engagement:** We work with communities on topics they feel are relevant to them and develop bespoke arts packages to tackle specific issues the community faces.
- **Theatre:** We pride ourselves on creating professional standard accessible theatrical productions that are created in consultation with the communities we are trying to engage with.
- **Injury Prevention:** We deliver special courses to people with visual impairment. These incorporate b-boying (Breakdance) as a means of injury prevention by improving spatial awareness.
- **Workshops:** We offer a variety of artistic workshops including:
 - Theatre Skills
 - Hip Hop Dance
 - Contemporary Dance
 - Disc jockey'ing and Music Production

2. Background

Rationale Arts officially received charity status in February 2019 from the charity commission. Our first board meeting took place on the 2nd of April 2019 and we have had regular board meetings since.



3. Review of 2023 -24

In our fifth year, we continued our mission to make art accessible by leveraging innovative approaches and forming strategic partnerships. Despite the lingering effects of the pandemic, we managed to deliver impactful programs and achieve significant milestones. Here's a detailed overview of our activities and accomplishments from 2023-2024.

3.1. Hip Hop Rehabilitation

From April 2023 to March 2024, we extended our Hip-Hop rehabilitation sessions at Sheffield Children's Hospital. Working closely with physiotherapists, we translated prescribed exercises into hip-hop dance movements. This year, our program supported children with conditions such as leukaemia, brittle bone disease, and traumatic brain injury. These sessions not only improved recovery times but also enhanced the families' relationship with the hospital. Our findings were presented at several medical conferences, showcasing the positive impact of integrating arts into healthcare.

Feedback from Physiotherapists and Occupational Therapists:

- "The sessions injected fun into therapy!"
- "The sessions helped the hospital feel less sterile and provided meaningful activities where children could have fun."
- "The music sessions allowed us to see the patient's potential in ways we cannot replicate in standard therapy sessions."
- "The energy from the hip-hop sessions had a lasting positive impact on the ward."
- "Parents loved seeing their children participate and often joined in, creating joyful shared experiences."

3.2. Injury Prevention Courses

We successfully delivered four 4-week injury prevention courses in partnership with Children in Need, Sheffield Royal Society for the Blind, and Sheffield International Venues. These courses featured our "sight-specific moves" curriculum, which teaches breakdance to individuals with visual impairments to enhance spatial awareness and prevent injuries.

3.3. Workshops and Mentorship Programs

-Summer 2023: Mentored young people from the LGBTQ+ community in Rotherham, culminating in dance performances at the Wowser's Festival and the prestigious Regional Mayor's Gathering at Wentworth Woodhouse.

- Easter and Summer 2023: Partnered with Rotherham United Football Club to deliver dance and circus sessions to children on the free school meals program.

- Graffiti Workshop: Conducted a graffiti workshop at Bluebell Wood Hospice for both sighted and visually impaired patients.

3.4. ACTs of Creativity

Our ACTs of Creativity initiative was expanded to include both mainstream and SEND students at Elmsmere Children's Centre. Additionally, we continued our partnership with Care for Young People's Future to deliver these sessions at Grimesthorpe Family Centre.



3.5. Theatre and Performances

- Christmas 2023: Provided breakdancing Santas for Sheffield Children's Hospital, where they performed and taught dance moves to children on the wards.

3.6. Keynote Speeches and Global Recognition

In November 2023, our Charity Director was invited to give keynote speeches at the Global Hip-Hop Conference in Los Angeles and at Texas State University, highlighting our charity's critical work and its global impact.

4. Finance Accounts

During the financial year 2023-24 the Charity received a total income of £40,470 and had a total expenditure of £40,052 with a total surplus of £950 (which includes monies carried over from the previous year). Since our inception as a Charity, we have managed to raise **£141,255** to '*make art accessible*'.

2. Background

Rationale Arts officially received charity status in February 2019 from the charity commission. Our first board meeting took place on the 2nd of April 2019 and we have had regular board meetings since.



3. Review of 2022 -23

Like many other charities, we focused on recovery post pandemic by adapting to the situation and to carrying on with our mission to make art accessible in ever more innovative ways.

3.1. Hip Hop Rehabilitation

Between April 2022 and November 2022, we delivered Hip-hop rehabilitation sessions at Sheffield Children's Hospital where we worked with physiotherapists to deliver engaging artistic sessions to promote recovery. The children we worked with had a variety of conditions ranging from Traumatic Brain Injury, Leukemia and Brittle Bone Disease.

Feedback from Physiotherapists and Occupational Therapists

"The sessions injected fun into therapy!"

"The sessions helped the hospital feel less sterile and provided meaningful activity and find a space where they could have fun."

"The music sessions allowed us to see the patient's potential in a way we cannot replicate in a standard therapy session."

"It was fantastic to see how the energy and fun from the hip hop session carried across to the next day. The energy from the first session lifted the whole ward and it had a positive impact for days."

"The parents loved to see their child joining in and the children loved to see their parents joining in too."

"It helped us connect positively with children and young people who were having a very difficult time."

"The children's faces lit up when we mentioned the Hip Hop artist was coming back in. They really looked forward to seeing him."

The results:

The hip hop and physiotherapy collaborative sessions were welcomed by children and young people, families, and therapists, with the experience being overwhelmingly positive. Parental feedback centred around the sessions improving energy, motivating and boosting mood. Therapist feedback referred to the sessions being fun, meaningful, connecting with children positively and being able to better understand a child's ability and potential.

The feedback from parents supports the encouragement of physical activity which is fun, safe and family-centred. It was tailored to each child's abilities, interests and goals. Parents often



joined in sessions with their child and encouraged them to join in, or asked to film sessions so they could share with the wider family, allowing the child to watch again and keep practising the dance steps between sessions, motivating the child be physically active outside of the session. Parental support is a known factor in encouraging children to be physically active.

3.2. Injury prevention courses

We were successful with our funding bid with the Children in Need to deliver our state-of-the-Art Injury Prevention course. We delivered the first course consisting of eight sessions in Autumn 2022 and the second course between February and March 2023 by working with Sheffield Royal Society for the Blind (SRSB) and Sheffield International Venues (SIV).

3.3. Workshops

- During August 2022 we delivered a variety of Breakin and hip-hop dance sessions in Barnsley as part of their summer festival.
- In February 2023 and March 2023, we delivered dance sessions for Reach Up Youth.
- We did a hip hop and graffiti workshop with Nottingham Children's Hospital Youth Service.

3.3. ACTs of creativity

We delivered ACT is Acceptance and Commitment Therapy to:

- Early years children at Ellesmere Children's Centre – May 2022 - July 2022, March 2023
- Care For Young People's Future at Grimethorpe Community Centre with a specific focus on the Roma community. May 2022 – June 2022
- Refugees at Sheffield's City of Sanctuary – June 2022
- 3 schools in the Glossop area in partnership with Derbyshire County Council – Autumn 2022

3.4. Theatre

In August 2022 Rationale Arts performed at an event called Paint Jam which was organized by Site Gallery as part of their Out and About series. The day was made up of some of Sheffield's best painters and artists coming together to reanimate Sheffield's Cultural Industries Quarter with vibrant paintings from Graffiti writers to visual artists. A DJ provided an energetic soundscape to the event, playing genres that spanned, funk, house and hip-hop.

In December 2022 we performed at Burn greave's light switch on event to a culturally diverse audience.

In January 2023 Rationale Arts performed at Rotherham Children's Capital of Culture Manifesto Launch at Gulliver's Valley.

4. Finance Accounts

During the financial year 2022-23 the Charity received a total income of £24,510 and had a total expenditure of £37,847 with a total surplus of £532 (which includes monies carried over from the previous year). Since our inception as a Charity, we have managed to raise **£100,785** to '*make art accessible*'.



1. Mission Statement

Rationale Arts is a registered charitable arts organisation with the key aims to promote, improve, and maintain public education and appreciation of the arts. Specifically, but not exclusively the art of dance, music, and theatre.

We aim to achieve our mission mainly through 4 avenues.

- **Community engagement:** We work with communities on topics they feel are relevant to them and develop bespoke arts packages to tackle specific issues the community faces.
- **Theatre:** We pride ourselves on creating professional standard accessible theatrical productions that are created in consultation with the communities we are trying to engage with.
- **Injury Prevention:** We deliver special courses to people with visual impairment These incorporates b-boying (Breakdance) as a means of injury prevention by improving spatial awareness.
- **Workshops:** We offer a variety of artistic workshops including:
 - Theatre Skills
 - Hip Hop Dance
 - Contemporary Dance
 - Disc jockey'ing and Music Production

2. Background

Rationale Arts officially received charity status in February 2019 from the charity commission. Our first board meeting took place on the 2nd of April 2019 and we have had regular board meetings since.



3. Review of 2021-22

Like many other charities, the ongoing Coronavirus Pandemic led to a significant downturn in Rationale's activity at the beginning of the financial year. However, we were determined to adapt to the situation and to carry on with our mission to make art accessible in ever more innovative ways.

3.1. Highlights

3.1.1. Our Charity Director Nathan Geering was awarded the prestigious award of RNIB 2022 community contributor of the year. <https://www.rationalearts.com/post/rnib-community-contributor-of-the-year-2022-nathan-geering>

3.1.2 Nathan Geering delivered the 'Final Word' at the Children's Media Conference on 9th July 2021 about our ground breaking work surrounding children from vulnerable backgrounds.

3.1.3. Trust in Care

We worked in partnership with Derbyshire Council and Derby Theatres in February 2020 for our first pilot Theatre production.

Then we worked with young people in care and people with disabilities throughout the year to finalise our Trust in Care theatre production. This had its first official performance in June 2021 at the Crucible theatre in Sheffield.

Trust in Care is truly a culmination of all the work the charity has been involved in since its inception in 2019 and we look forward to developing the show further and going on a national tour in the coming years.

3.2. Injury prevention courses

We bid for £20,000 to the Postcode Lottery to deliver our state-of-the-Art Injury Prevention course in 20-21. This bid was successful.

Responding to the pandemic restrictions, we created online content which was accessible for visually impaired people. We have begun to transfer our face-to-face content to online learning - to try to spread our work as widely as possible. We have successfully delivered online injury prevention courses to people with visual impairment across the country. We've been able to carry on with work in 21-22



The sessions not only prevented injury but also addressed the increase in social isolation and loneliness amongst the sight loss community. This has been further heightened by the Pandemic.

3.3. Workshops

We collaborated with Bluebell Wood Hospice and delivered hip-hop handplay and smashing street art sessions both face to face and virtually.

We have recently started a project with Sheffield Children's Hospital and their in-house therapy team to create hip hop rehabilitation. This project will run over the next few months.

As part of the Showroom Cinema's Anime Festival, we taught children how to draw anime characters - through Graffiti workshop.

3.3. ACTs of creativity

ACT is Acceptance and Commitment Therapy. Over the past year we have successfully delivered Socialising Mindfulness (also known as ACTs of Creativity) sessions to schools in the Bolsover district.

The initial plan was to deliver the sessions in a mixture of primary and secondary schools. However, many secondary schools were overwhelmed with the integration of students transitioning from home learning back to face-to-face learning. So, we - and our partners - concluded that it would be more beneficial to focus on delivering face to face sessions to primary schools and one SEN school.

Therefore, the schools we worked with were:

- Arkwright primary school
- Brockley primary school
- Duckmanton primary school
- Bolsover primary school
- Stubbin Wood SEN School.

The sessions in each school were a huge success and had an instant positive impact on the children. With every session, children were reporting increases in emotional well-being which was measured by children rating how they were feeling on a scale of 1 to 5.

- 1 - Feeling very bad
- 2 – Feeling bad
- 3 – Feeling Ok
- 4 – Feel good
- 5 – Feeling amazing

These measures were taken at the beginning of the class and then again at the end of the class. Generally, most children had a substantial increase in their mood by the end of the session when compared with their mood at the beginning of each session. Even after just two weeks children were taking the initiative and teaching their siblings and parents the dance meditation techniques. These could be - and were - implemented at home during emotionally challenging times.

The digital content that we created worked particularly well to incite initial interest in school staff. This helped cultivate relationships and further developed an ongoing appetite for the sessions. The digital content has also been used to deliver challenges based on the 5 ways to well-being to pupils in schools.

Teachers also reported improvements in children's well-being and said they would definitely recommend the ACTs of Creativity sessions to other schools. In addition to this all of the involved schools have expressed an interest for the sessions to continue in September. In total we have delivered a minimum of 50 sessions and have engaged with a minimum of 115 children. We have trained 4 members of staff and provided continuing support so they can continue to deliver their sessions to the highest standard. We have received written quotes from many of the children and teachers that took part in the activity. Here are a couple of examples of the quotes we have received:

We have also delivered ACTs of Creativity Sessions to BAME Communities in Sheffield. This was part of an initiative to improve mental health and emotional wellbeing and so to reduce the adverse effects of the pandemic on Children and young people.

3.4. Festival in the Square

Last August, Rationale Arts was given the amazing opportunity to be a part of a brand new two week festival: Festival on the Square, in Tudor Square Sheffield. Its goal was to highlight the creative arts in the city and included workshops, performance, music and movie screenings.

Rationale Arts gave outdoor dance sessions that focused on Hip Hop and breathing techniques. Specifically, we showed how Breakin’ and Popping can act as a form of meditation when combined with controlled breath work.

Participants learnt some of the fundamentals of the dance forms and were given an introduction to how our emotions and performance can be affected, and therefore controlled, by breathing techniques.

These sessions offered an exciting and welcoming environment for people of all ages. Some people returned for multiple sessions through the duration of the festival.

We feel fortunate to be able to lead these sessions and so give back to the community we grew up in by sharing the knowledge we have about HipHop and Rationale Arts.



3.5. Tales from the playground

In the summer of 2021, we were invited to take part in Sheffield's HAF 'Holiday Activities and Food' scheme. This programme aims to make free 'holiday club' places available. It is locally-coordinated by Tales from the Playground.

We delivered mindful street-dance workshops which aimed to utilise the physical and mental benefits of street-dance, and provided opportunities to build key-skills such as mindfulness, problem-solving and confidence using a variety of methods. 'Be kind to others and be kind to yourself' is the simple phrase we reminded the students while they learnt moves and performed.

We believe it is key to make everyone aware of positive mindsets. This enables us all to enjoy the process of learning and creates a supportive environment for the individual as well as those around them. Plus, if a student can really take on-board a positive mindset, then they have the power to lead-by-example and influence their peers outside of the initial setting.

It was a pleasure to meet and teach local communities especially since the scheme enabled the workshops to be accessible for underprivileged areas and families. Every place we visited was very welcoming and provided space for us to deliver the workshops. On some days we conducted sessions inside a youth centre or hall, but when the weather was good weather days we utilised local playgrounds and fields.

Regardless of the venue it was good to provide positive associations wherever we taught. This highlights to the children that even outside of school their local area supports fun, learning and their own development as individuals.

The number of children involved varied from session to session, but it was lovely and reassuring that many children revisited with enthusiasm. Parents and caregivers gave positive feedback and expressed their interest for more sessions in the future. With regards to future sessions, we have recently been contacted to deliver more workshops at the end of December 2021. We are excited to engage with these communities again: it's another chance to establish key-skills supporting physical, plus mental development through communities. The art-form of dance provides all this and more in fun and positive processes.

3.6. Hip Hop Horror Show

For Halloween 2021 Rationale Arts performed our fully Immersive Hip-hop horror show at Theatre Deli. The production was originally performed at Theatre Deli Sheffield's Woolworths venue back in 2014 as part of Horror Souk. This production was incredibly unique as it was the first ever fully immersive Hip-Hop Horror show of its kind, featuring street dancing



skeletons and chilling hip hop soundtracks. The show was such a huge success that it was bought back for multiple performances in subsequent years to wow audiences with its unique blend of hip hop dance and jump scares all whilst navigating your ways through an eerie basement. Fast forward to 2021 Theatre Deli has moved venues and had at the time taken over an old Mothercare building. This posed new opportunities to further develop our show. The new layout meant that there was a lot of open space which meant that we would have to rethink the audience's journey and create new ways of scaring the living daylights out of those who dared to set foot in our Hip-Hop Horror venue. Our new show levelled up in some ways as incorporated Hip-hop Contortion, fire-eating with storytelling, fire sword performances, audience members performing for their undead audiences and scary aerial slings.

The most noteworthy change was that we converted the entire open space into a scare-maze which meant we had the freedom to create a bespoke audience journey within the space.

All of this refinement contributed to another sell out run of our Hip-hop horror show with audiences saying it was the scariest thing they had experienced throughout Halloween. So be sure to stay tuned for 2022's Hip-Hop horror show as rumours are already circulating that this one could be the scariest one ever as it may take place in one of Sheffield's old museums. One thing that is for sure is that Rationale Arts blend of Hip-Hop and horror is a winning combination.

4. Other Activities

- We further developed a state-of-the-art website showcasing our work which can be accessed at www.rationalearts.com.
- Our first ever scientific report reflects on the 'ACTs of Creativity' project delivered in schools across Derbyshire, England. This highlighted some of the therapeutic benefits of Hip Hop, focusing on Breakin' and mindfulness and shared some of the tools and strategies we used in schools with pupils. We continue to reflect on pupil, teacher, and practitioner feedback to consider the next steps for ACTs of Creativity in schools.

5. Finance Accounts

During the financial year 2021-22 the Charity received a total income of £30,519 and had a total expenditure of £29,430 with a total surplus of £13,869 (which includes monies carried over from the previous year). Most of the surplus was created as we are still delivering some of work which we were granted funding for and we have recently received a grant to cover core charity costs. Since our inception as a Charity, we have managed to raise **£76,275** to '*make art accessible*'.

- **Theatre:** We pride ourselves on creating professional standard accessible theatrical productions that are created in consultation with the communities we are trying to engage with.
- **Injury Prevention:** We deliver special courses to people with visual impairment that incorporates b-boying (Breakdance) as a means of injury prevention to improve spatial awareness.
- **Workshops:** We offer a variety of artistic workshops including:
 - Theatre Skills
 - Hip Hop Dance
 - Contemporary Dance
 - Desk jockey'ing and Music Production

2. Background

Rationale Arts officially received charity status in February 2019 from the charity commission. Our first board meeting took place on the 2nd of April 2019. The Trustee's went through a rigorous process of setting up a Bank account etc subsequently and it was not until end of May 2019 that we were able to make our first funding bid to the National Lottery. During the initial period we set up various social media platforms on Twitter, Facebook, and Instagram to develop a presence and promote the work we were aiming to do. We also reached out to various stakeholders locally with the aim of building relationships and creating pathways to achieve our mission.

3. Review of 2020-21

Due to Coronavirus Pandemic, there was a significant downturn in the charity's activity at the beginning of the financial year. UK went into Lockdown in March 2021 which significantly affected the charity activity; however, we were determined to adapt to the situation and carry on with our mission to make art accessible albeit in a more innovative way.

3.1. Injury prevention courses

We were successful with our funding bid of £20,000 to the Postcode Lottery to deliver our state-of-the-Art Injury Prevention course, due to the pandemic we created online accessible content for people with visual impairment and begun to transfer our face-to-face content to online content, we have successfully delivered online injury prevention courses to people with visual impairment across the country. When asked about our Virtual Sessions, one of our students replied:



This is a great opportunity for anybody who is blind or lives with a visual impairment, or for anyone that has general accessibility issues. Coming from someone who has had multiple break sessions over Zoom now I can 100% recommend it to anyone that is looking to improve their spatial awareness, learn something new, keep fit and challenge themselves in a completely new way. Even if you aren't a Dancer, it is a really cool, accessible and safe way to get you back moving and on your feet.

We will continue to deliver this online visual impairment course until April 2021.

3.2. Workshops

We have collaborated with Bluebell Wood Hospice and delivered hip-hop handplay and smashing street art sessions both face to face and virtually. We were also involved in with Bluebell Wood for their bonfire night and Christmas Elf performances which were heavily featured in the local media.

3.3. ACT's of creativity

We were granted £10,000 funding by Derbyshire County Council to create content for our ACTs of Creativity initiative which we will be rolling out to 4 schools in the Bolsover area from April 2021 onwards. Through the ACTs of Creativity promotional material, we were able to employ and mentor people of colour on artistic film making.

3.4. Blackfest

We formed a partnership with Blackfest to deliver dance sessions to people with Disabilities between January 2021 and March 2021.

3.5. Trust in Care

Following on from our first pilot Theatre production working in partnership with Derbyshire Council and Derby Theatres in February 2020 we worked with young people in care and people with disabilities throughout the year to finalise our Trust in Care theatre production which will have its first official performance in June 2021 at the Crucible theatre in Sheffield.

The show features one of the young people with visual impairment that we delivered our injury prevention course as the main character. Trust in Care combines Hip-Hop, Street dance, Interactive Projection, beatboxing and Poetry to tell the dynamic story of two siblings trying to navigate their way through the care system. Along the way, they meet foster carers and creative mentors that help them reflect on what it means to be a family and trust new people who enter their lives. With a diverse cast of performers who are disabled and non-disabled as well as performers from LGBTQ communities and culturally diverse backgrounds, Trust in Care will deliver on so many levels. The production was created with young people in care as the artistic consultants and provides an emotive insight into the lived experience of looked after children and young people.

Trust in care is truly a culmination of all the work the charity has been involved in since its inception in 2019 and we look forward to developing the show and going on a national tour in the coming years.



4. Other Activities

- We further developed a state-of-the-art website showcasing our work which can be accessed at www.rationalearts.com.
- We invested in equipment to provide workshops; this equipment will serve the community well in the years to come.
- We gained national recognition for our work with one of our visual impaired students being featured on BBC's Strictly it takes two.

5. Finance Accounts

During the financial year 2019-20 the Charity received a total income of £10,751 and had total expenditure of £8,949 which left a surplus of £1,802. During the financial year 2020-21 the Charity received a total income of £35,005 and had a total expenditure of £24,027 with a total surplus of £12,781 (which includes monies carried over from the previous year). Most of the surplus was created as we are still delivering some of work which we were granted funding for and unpaid invoices for delivering the Injury prevention course and Trust in care. Any Surplus is used towards the running costs of the Charity such as Insurance and other relevant subscriptions.

Since our inception as a Charity, we have managed to raise **£45,756** to '*make art accessible*'.
