These donations provide reassurance and confidence to those who most need it.</p> <p>Donations granted to local community organisations, projects and charities which protect and support vulnerable people throughout the Warwickshire area. The recipients of the funding were able to apply directly to the charity with each application being considered on an individual basis by the Trustees. Donations were granted to those projects and charities within the Warwickshire county that were making such a difference to the people in their local communities.</p> <p>Donations were granted to projects for the young, elderly, homeless, disabled and disadvantaged.</p>

Para 1.20	<p>Throughout the 2 ½ years the charity has been running, it has helped various people that have suffered as a result of crime with either a financial donation or goodwill gesture. In this financial year, examples of donations which have been issued include to a young mother who was attacked in a park after confronting some youths causing damage as well as a family whose car was stolen overnight which contained their baby's pram and car seat and they could not afford to replace. These donations made a huge difference to the individuals when they were feeling at their most vulnerable and distressed.</p> <p>These small gestures had such an impact on the victims' - it restored</p>

		<p>their faith in human nature and reassured them that people do care. It also had a huge positive effect for the police officers and police staff who delivered the donation for them to see what a difference it made to the victim.</p> <p>The charity has also provided financial donations to a number of local community charities within the Warwickshire area. This was very much welcomed by the charities, projects and organisations concerned and by receiving these additional funds it allowed them to provide help to more vulnerable people.</p> <p>Recipients included an organisation that provides support for individuals with a learning disability or those with mental health issues where they can learn new skills and use them with confidence. Funding was granted for online virtual support to ensure the support was still fully available throughout the pandemic. Other donations issued also included a contribution towards play park equipment for children of all disabilities within the county of Warwickshire; and equipment for a boxing club aimed at young people, offering intervention to prevent them being drawn into county lines drug dealing.</p>

## Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	<p>The charity was first registered in August 2018 and the accounts opened with a balance of £101,304.91. These original funds were the sale proceeds of seized property, seized and found cash. The Chief Constable has the discretion to distribute these funds on an annual basis to any charity she chooses. The Trustees of the Fund are very keen to help the local Warwickshire community and setting up this charity with these funds was an ideal solution.</p> <p>The income received in the financial year 21/22 was again a contribution from the sale of seized property which has given the charity a healthy balance.</p> <p>The number of applications for donations was slightly lower than the Trustees had hoped for with the result at the end of the year being a higher than anticipated balance of £54,020.83.</p>
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	It is still the Charity's intention to spend donations in the year of receipt. However, with the reduced number of donation requests in 21/22 and carrying forward a balance of £45,979 from the previous year, it has been a challenge to reduce the overall balance. It is therefore necessary for the remaining funds be carried forward to the next financial year but the Trustees would expect any future reserves to be a relatively low level.
