Activities: PROMOTING LEARNING AND PERSONAL DEVELOPMENT OF WOMEN THROUGH EG LECTURES COVERING DISCIPLINES SUCH AS THE ARTS, CULTURE, HEALTH AND SOCIAL WELFARE, PARTICIPATION IN GROUPS WITH ACTIVITIES SUCH AS ARTS AND CRAFTS, WALKING. ENCOURAGING MEMBERS TO TAKE AN INTEREST IN ISSUES OF NATIONAL AND LOCAL IMPORTANCE PARTICULARLY RELEVANT TO THE LIVES AND WELFARE OF WOMEN. FUNDRAISING FOR LOCAL CHARITIES.
