Summary of the main achievements of the charity during the year

The start of the year presented significant challenges for the church, particularly surrounding our venue transition. Following our abrupt departure from St Philip's, we continued meeting at St Christopher's Prep School Hall. This period required much prayer, careful planning, and considerable diligence from the leadership team.

We are grateful to report that our subsequent move to Hounsom Memorial Church in Hove has brought much-needed stability, both relationally and financially. This new base has provided consistency, a sense of belonging, and a renewed confidence within the congregation.

Alongside this move, we also adjusted our meeting time from 11am to 2pm. While this was initially a logistical necessity, it has become a surprising point of growth. The later time has opened the door to families whose children have sports commitments on Sunday mornings, and we are already seeing the benefit of this increased accessibility.

Sunday Church

Our Sunday gatherings have seen positive and encouraging growth, largely due to the venue change and the increased accessibility of our new meeting time. There is a renewed sense of momentum, and we are seeing fresh engagement from both existing members and newcomers.

Our congregation remains wonderfully diverse, with ages ranging from infants to the elderly. Notably, we have also seen an increase in attendance from asylum seekers, which reflects our heart for inclusivity and hospitality.

Another encouraging outcome of the venue transition has been an increase in Sunday volunteers. More people are stepping forward to serve, which is helping to build a stronger sense of shared ownership and community.

Kids & Youth Work

Our children's and youth work continues in person, though currently in a more limited format. At present, we run Children's Church on occasional Sundays rather than weekly. On most Sundays, children remain in the main service, supported by an activities corner.

This scaled-back approach is largely due to a shortage of volunteers for children's ministry. While this remains a challenge, we are committed to developing this area sustainably and prayerfully, ensuring that any future expansion is well-supported and safe.

Small Groups

We continue to host our Bible Study small groups online via Zoom. These have proven to be both accessible and popular, with a consistent number of regular weekly attendees.

Nicky has spearheaded these groups, providing leadership, structure, and pastoral care. The online format has enabled participation from those who might otherwise struggle to attend in person, including those with health, childcare, or transport limitations.

Prayer Life of the Church

One of our core aims this year is to deepen our culture of prayer—both individually and corporately. We are encouraging the church to engage more intentionally in prayer and fasting, recognising that spiritual depth must underpin all growth and activity.

This remains a key area of focus moving forward, shaping not just what we do, but who we are becoming as a community.

As the church continues to grow, our focus will be on engaging new donors by improving the accessibility and clarity of our giving processes. This includes making digital giving easier to use, increasing awareness of Gift Aid, and actively encouraging more regular givers to enrol in Gift Aid schemes where eligible. These steps will help strengthen our long-term financial sustainability.


