EDUCATION

We have partnered with six schools in Thyolo: Mambala Primary School, Nahache Primary School, Namachila Primary School, Naphiyo Primary School, Ntundama Primary School and Nyambalo Primary School.

Resources

We build classroom blocks for our partner schools because in rural Malawi there is a lack of safe infrastructure and as a result, many children are learning outside. Children are being denied the chance to access a high-quality education and with students lacking the resources to learn, many lose hope and drop out. Our classroom block builds have caused attendance figures to increase in our partner schools.

We also build toilet blocks for our partner schools as many girls in Africa miss school during their menstrual cycle. By some estimates, this equals to as much as twenty percent of a given school year. Many girls drop out of school altogether once they begin menstruating.

We build safe toilet blocks (separate toilets for boys and girls, doors with locks, space for changing). This is with the aim of reducing dropout rates.

All of our resources are bought from local businesses and all of our building work is done by local, skilled tradesmen.

Education Plus Packages

We support our partner schools' most vulnerable children via our Education Plus Packages. Many are academically able but due to poverty, are at risk of dropping out. Headteachers in our partner schools identify these pupils, many of whom have to engage in manual work to earn money to pay for the basic resources needed to complete school.

We offer vital support in the form of fees, books, uniform, resources, food and toiletries for pupils with the aim of lowering dropout rates and increasing the number of school leavers going on to further education or employment.

In selecting individuals for appointment as charity trustees, the charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

RETIREMENT AND REMOVAL OF TRUSTEES

A charity trustee ceases to hold office if he or she:

- i. retires by notifying the CIO in writing (but only if enough charity trustees will remain in office when the notice of resignation takes effect to form a quorum for meetings);
- ii. is absent without the permission of the charity trustees from all their meetings held within a period of six months and the trustees resolve that his or her office be vacated;
- iii. dies;
- iv. in the written opinion, given to the CIO, of a registered medical practitioner treating that person, has become physically or mentally incapable of acting as a charity trustee and may remain so for more than three months;
- v. is disqualified from acting as a charity trustee by virtue of sections 178-180 of the Charities Act 2011 (or any statutory re-enactment or modification of that provision).

Any person retiring as a charity trustee is eligible for reappointment.

EDUCATION

We have partnered with six schools in Thyolo: Mambala Primary School, Nahache Primary School, Namachila Primary School, Naphiyo Primary School, Ntundama Primary School and Nyambalo Primary School.

Education Plus Packages

We support our partner schools' most vulnerable children via our Education Plus Packages. Many are academically able but due to poverty, are at risk of dropping out. Headteachers in our partner schools identify these pupils, many of whom have to engage in manual work to earn money to pay for the basic resources needed to complete school.

We offer vital support in the form of fees, books, uniform, resources, food and toiletries for pupils with the aim of lowering dropout rates and increasing the number of school leavers going on to further education or employment.

Resources

We build classroom blocks for our partner schools because in rural Malawi there is a lack of safe infrastructure and as a result, many children are learning outside. Children are being denied the chance to access a high-quality education and with students lacking the resources to learn, many lose hope and drop out. Our classroom block builds have caused attendance figures to increase in our partner schools.

We also provide educational resources in the form of books, stationery and toiletries to over 1000 orphans in Thyolo.

All of our resources are bought from local businesses and all of our building work is done by local, skilled tradesmen.

EDUCATION

Education Plus Packages

We support our partner schools' most vulnerable children via our Education Plus Packages. Headteachers in our partner schools identify these pupils, many of whom have to engage in manual work to earn money to pay for the basic resources needed to complete school. We are currently sponsoring 12 pupils in the form of fees, books, uniform, resources, food and toiletries with the aim of lowering dropout rates and increasing the number of school leavers going on to further education.

Resources

In Thyolo many schools are under-resourced and understaffed with certain schools employing one teacher for 200 pupils. There is a lack of infrastructure and as a result, children are being denied the chance to access a high-quality education. Many schools have very poor sanitation and pupils are forced to learn outside in an environment without basic classroom equipment. SEED has provided educational resources to all 218 orphans at Nyambalo School, all 251 orphans at Naphiyo School, all 189 orphans at Mambala School, all 209 orphans at Namachila School, all 229 orphans at Ntundama School and all 202 orphans at Nahache School.

SEED also successfully built a classroom block at Nahache School. This has transformed the community and has caused attendance figures at the school to increase.

All work was done by qualified country nationals and all resources and materials were bought from local businesses.
