This long-term collaboration with Evolutionary Arts Hackney (EarthH) further establishes the charity's position as a community music provider offering a range of services to local young people and building a number of new partnerships with local organisations.</p> <p>The public benefits of the charity's projects include but are not limited to:</p> <p>1) Assisting young people ages 12 to 25 and advancing their education in contemporary music making across the year (both during the school day and after school, as well as school holidays), to ensure continued access</p> <p>2) Providing access to professional level music making facilities in state-of-the-art Studio 36 and one-to-one support for music career development and in creating artist portfolio assets</p> <p>3) Promoting community engagement by delivering these projects with partners across Hackney and Tottenham, including a long-term collaboration with EarthH</p>

Para 1.20	<p>The charity's ambition to provide young people with access to high-quality music development opportunities has been further realised by the establishment of Studio 36. This long-term collaboration with Earth amplifies the charities impact by giving over a dedicated space that is a safe and nurturing environment for young people.</p> <p>The charity continues to deliver its core programmes providing young people with access to music making facilities and professional support as well as continuing to be a delivery partner for organisations like Hackney Empire and Selby Centre.</p> <p>The charity piloted a new programme with Pupil Referral Units to engage students who have been partially or fully excluded from mainstream education, helping them to work towards and complete Arts Award qualifications. This pilot programme was so successful that the partner organisation, The Pears Family School in Islington, has decided to commit to the project for the entirety of the next academic year.</p>
