In this difficult year, the charity has continued to rehome dogs, finding homes for a total of 58 dogs (2020: 60 Dogs).

One of the charity's sole aims is to acquire a piece of land in the UK to build a rehoming centre. This will enable the charity to help rehome more dogs, but also, provide a bespoke centre for training dogs with behavioural issues.


