The charity is governed by a trust deed.

The trustees meet as needed to oversee the charity's activities.

No paid staff; all work is done by volunteers.

3. Objectives and Activities

The Abbey School (Farnham) Trust supports past and present pupils of the Abbey School by providing extra resources and activities where there is no statutory funding. The charity provides education to the public and makes grants to current and previous pupils of the school where the trustees see fit.

Activities this year included receiving donations to support a new minibus purchase, sending underprivileged students with SEND on a ski trip to Italy, and supporting disadvantaged students to attend the Year 11 prom.

4. Achievements and Performance

The charity received £57,911 in donations.

It donated £7,588 to support the activities mentioned above.

The trustees are satisfied that the charity has met its objectives for the year.

5. Financial Review


