Para 1.20	<p>In FY 2023, the charity continued to expand its Mental Health First Aid training offers as set out in the summary of activities above.</p> <p>Expanded and diversified the Level Up Mental health programme with companies within the videogames industry, with now over 150 publishers, developers and service providers promoting and implementing mental health policies and best practice.</p> <p>The charity implemented a new structure for recruiting Ambassadors whereby each year a new class of supporters are engaged to help spread awareness of the charity in what it's doing to foster mental health awareness, as well as future goals and initiatives.</p> <p>The charity also conducted a successful trustee recruitment process, hiring three new trustees with experience and connections to the games industry. The trustees bring additional skills in finance, business development, governance and fundraising.</p> <p>Executed two large public mental health awareness campaigns in May and October.</p> <p>Attended many events/panels/talks/presentations in support of the charities mission to eliminate the stigma surrounding mental health and make it a natural topic of discussion.</p>

Investments were made into new staff to help deliver content and fund raise.</p>
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	<p>Year end reserves are £191k, with free funds of approximately £150k. Overheads for FY 2023/24 is approximately £115k required for salaries and running costs. The target reserves to be held are approximately 6 months of overheads, with a minimum amount of 3 months of overheads. The reason for those targets is to allow for sudden financial shocks and drops in income ensuring the charity can continue to support the global games industry effectively.</p> <p>The remaining balance will continue to be invested in training courses, initiatives to fundraise for further work and new initiatives in driving our partner programmes.</p>
