2 - To further or benefit the residents of Enfield and surrounding areas, without distinction by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the objective of improving the conditions of life for the residents. In furtherance of these objects but not otherwise, the trustees shall have power to establish or secure the establishment of a community centre and to maintain or manage or co-operate with any statutory authority in the maintenance and management of such a centre for activities promoted by the charity in furtherance of the above objects.

**Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)**

To hold weekly Friday Jummah prayers a hall was hired for limited time every week. Without a dedicated full-time facility, the community activities have been limited.

In a year of the pandemic much of the community services had been suspended to follow the government guidelines of indoor gathering. Weekly prayer services resumed upon lifting of the restrictions, and much effort was made by all volunteers to implement all social distancing measures.

The trustees have successfully completed the purchase a new property in 2019, and then engaged the local planning authority to obtain the planning change of use for the intended community services.

After fulfilling all the planning authority requirements, ETIC planning application was approved. This represented a milestone in the ongoing effort to continue to deliver the charity objects.

Trustees have begun the process of full renovation to ensure the property is reconfigured to provide a multipurpose community hub with prayer facilities, social activities, library and community engagement facility.

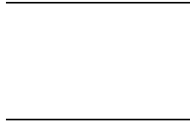
