Our primary risk management procedures are to only fund work that we know personally and is being delivered by people we know. We also seek independent reports from people that we know to attest to the impact of the work; that it is well governed and that issues such as Safeguarding are properly overseen and managed.

Grant activity has stayed at expected given the budgets received and approved from the work in Nepal.

The grants to Veritas work in Nepal (integral mission training) have ceased.

Objectives and activities

Summary of the objects of the charity set out in its governing document

For the public benefit, the relief and assistance of people in need in Nepal who are victims of economic or social disadvantage or catastrophe and advancing the education of these people for the public benefit by making grants and awards to organisations that provide safe housing and education and by making grants and awards to students or other people in full time education.

In governing the charity and planning its activities the trustees are aware of and give regard to the guidance on public benefit issued by the Charity Commission.

The trustees make grants to organisations that provide relief and assistance for people in Nepal who are the victims of social disadvantage.

In the year that this report covers, trustees continued to make grants to organisations they know personally and that have a track record in identifying people who are the victims of social disadvantage and providing them with safety and education.

Grants were made to a hostel based in Pokhara, Nepal that takes in children who are subject to abuse and cruelty and whose families (if they exist) are unable to look after them. The children are provided with good quality accommodation, a safe family environment and a good education. The hostel is registered with the Nepali authorities and its activities are overseen by a committee, independent from the hostel workers, drawn from local churches. During the year trustees have had video calls with the home manager and shared information with medical missionaries from Switzerland who co-fund the work.

As a result of these grants:

- Young people who otherwise would have been at risk have been kept safe
- Young people have been freed from cruel and abusive situations.
- Twenty-two young people have progressed their education within the Nepal system with their fees paid for

Additional details of objectives and activities (Optional information)

The trustees have engaged with the Board of the hostel with a view to the hostel operating with less dependency on external funding.

The trustees are pleased that the Board of the hostel have a plan to transition to a community-based model of care that will be more sustainable in that it will rely less on donations from outside Nepal.

For the last few years, the Board of the hostel has not been admitting children younger than the youngest in the hostel.

The Trustees of the Nepal Development Association recognise the difficulty of this transition as there are 22 vulnerable young people directly affected by decisions. The trustees are happy that we have in place the necessary funding to allow the hostel to manage through this transition process

The trustees run the affairs of the charity so that all monies raised less bank charges are invested in charitable work. The trustees' policy on grant making is to support organisations that it knows well. Donations come from people who also know the work in Nepal through personal connections.

There are no staff employed and the trustees manage all communications with supporters and make sure that feedback on the effectiveness of the grant making is secured.

Summary of the main achievements of the charity during the year

The main achievements of the charity has been to be able to continue with its grants that support work in Nepal amongst disadvantaged people.

Grants of £20,146 total were made to the hostel in Nepal (Pokhara) phased in line with the budget seen and approved by the trustees. This allowed the hostel to accommodate and educate twenty-two young people and to support some of the young people into vocational training and further education.

During the year we have also been able to talk with the hostel about how we taper our grant support as referenced in the earlier section of this report.

During the year we have been provided with regular reports and are encouraged that the hostel has been able to educate and support very vulnerable children though another challenging year.

The charity has no operating costs. Our reserves policy is to ensure that we have sufficient money in the bank so that together with committed donations and grants we have sufficient to cover any grants commitments made over the next twelve months.

The principal source of funds are people who know the work in Nepal through personal contact with some of the (previously) UK based development workers who engaged in starting up the Nepali work. Most of the people who support the charity are associated with Christchurch Harpenden where the development workers used to worship, and which used to support the work direct before this charity was formed.

Grants are also secured on a similar basis and the Kunde Foundation has similar links to the work in Nepal.

We have not applied for grant support – support has been offered by people who know the value of the work in Nepal.

This is a grant making charity and its only administrative expense in the year are bank fees. All other expenditure goes via grants to support work amongst disadvantaged people in Nepal.
