## **TRUSTEES' REPORT**

The Trustees present their annual report together with the financial statements of Lions Clubs International District 105N Foundation, a Charitable Incorporated Organisation (the Foundation) for the 12-month period ending 30 June 2025. The Trustees confirm that the Annual Report and financial statements of the Foundation comply with the current statutory requirements, the requirements of the Foundation's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2015.

### **Structure, Governance and Management**

The Foundation was registered as a Charitable Incorporated Organisation on the 3rd June 2019.

The Constitution stipulates that the minimum number of trustees shall be five and the maximum twelve. Six District Officers shall be ex-officio trustees of the Foundation, these are the District Governor, 1<sup>st</sup> Vice District Governor, 2<sup>nd</sup> Vice District Governor, District Treasurer, District Secretary, and the Immediate Past District Governor.

There should also be a minimum of two and maximum of six appointed trustees. No trustee can be appointed without the permission of the District Governor.

In the year 2024/2025 there have been eleven trustees in post, six of whom were ex-officio officers and five appointed trustees.

The process for the appointment of trustees is stipulated in the Constitution. Any trustee may call a meeting of the trustees. Meetings of the trustees are managed in accordance with the governance of the Foundation as set out under the Charitable Incorporated Organisation Constitution.

The Foundation's insurance requirements are covered under Lions Clubs International Multiple District 105 insurance arrangements.

## FOUNDATION

The trustees confirm they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the Charity Commission's general guidance on public benefit 'Charities and Public Benefit'. This year the Foundation has continued to provide public benefit, and we will explain how this has been achieved in this report.

All the administration expenses of the Foundation are dealt with through District 105N's 'Administration Account' the balance of which does not include any money raised from members of the public. The amount of expenses for travelling to meetings and room hire, for the period of these financial statements, was zero as all meetings were conducted through zoom.

District 105N consists of 66 separate Lions Clubs. Each club is autonomous and can decide on what Charitable donations they make. If a club decides to donate to a project or appeal from the international organisation, the Multiple District or the District, then those funds will be channeled through the Foundation. The trustees can confirm that the only liabilities that the Foundation does have relate to funds held with the Foundation's accounts pending the progression of these projects or appeals.

During the past year the Foundation has not raised any funds directly from the public, although this is something that the Trustees may consider in the future. The Foundation has grant-making criteria, under which any applications would be considered by the trustees at their meetings.

During the year the Foundation was registered with the HMRC for Gift Aid.

### **Financial Review**

During the year, the Foundation received income from donations from Lions Clubs within the District. In 2024/2025 the total received was £85,022.46 with a further £173.26 received in Gift Aid.

The sum of £57,223.17 was spent on charitable activities during the year. The highlights in the year were the raising of £44,065.09 towards the Lions Clubs International Foundation (LCIF) with £14,654.14 going towards the project to provide stoves for families in Ukraine, and the raising of £16,666.68 towards the Martin House (Children's Hospice) Den Project.



The trustees can confirm that the only liabilities that the Foundation does have relate to funds held with the Foundation's accounts pending the progression of these projects or appeals.

During the past year the Foundation has not raised any funds directly from the public, although this is something that the Trustees may consider in the future. The Foundation has a grant making criteria, under which any applications would be considered by the trustees at their meetings.

## **Financial Review**

During the year, the Foundation received income from donations from Lions Clubs within the District. In 2023/2024 the total received was £103,067.56

The sum of £107,169.52 was expended on charitable activities during the year. The highlights in the year were the raising of £44,285.92 towards the Lions Clubs International Foundation (LCIF) with £10,940 going towards the project to provide stoves for families in Ukraine, the raising of £22,943.22 towards the St Johns Hospice Project in Doncaster, half of which was raised by the clubs in the Doncaster area and matched funded by the LCIF. The sanctuary appeal at Martin House Children's Hospice received matched funding of £22,265 from LCIF.

Work has been ongoing to review the Youth Funds held by the district. As part of this review the trustees decided to incorporate the District 105NE Youth Fund, The District N Youth Fund and the ROAR project fees into one single fund called District 105N Youth Fund.

The Trustees confirm that the Annual Report and financial statements of the Foundation comply with the current statutory requirements, the requirements of the Foundation's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2015.

### **Structure, Governance and Management**

The Foundation was registered as a Charitable Incorporated Organisation on the 3rd June 2019.

The Constitution stipulates that the minimum number of trustees shall be five and the maximum twelve. Six District Officers shall be ex-officio trustees of the Foundation, these are the District Governor, 1<sup>st</sup> Vice District Governor, 2<sup>nd</sup> Vice District Governor, District Treasurer, District Secretary, and the Immediate Past District Governor.

There shall also be a minimum of two and maximum of six appointed trustees. No trustee can be appointed without the permission of the District Governor.

In the year 2022/2023 there have been nine trustees in post, four of whom were ex-officio officers and five appointed trustees.

The process for the appointment of trustees is stipulated in the Constitution. Any trustee may call a meeting of the trustees. Meetings of the trustees are managed in accordance with the governance of the Foundation as set out under the Charitable Incorporated Organisation Constitution.

District N consists of 71 separate Lions Club. Each club is autonomous and can decide on what Charitable donations they make. If a club decides to donate to a project or appeal from the international organisation, the Multiple District or the District then those funds will be channeled through the Foundation. The trustees can confirm that the only liabilities that the Foundation does have relate to funds held with the Foundation's accounts pending the progression of these projects or appeals.

During the past year the Foundation has not raised any funds directly from the public, although this is something that the Trustees may consider in the future. The Foundation has a grant making criteria, under which any applications would be considered by the trustees at their meetings.

## **Financial Review**

During the year, the Foundation received income from donations from Lions Clubs within the District. In 2022/2023 the total received was £150,656.41.

The sum of £152,369.36 was expended on charitable activities during the year. The highlights in the year were the raising of £47,188.97 towards the Lions Clubs International Foundation (LCIF) disaster fund for Turkey and Syria Earthquake, the raising of £33,475.58 towards the Serenity Project at Doncaster and Bassetlaw Hospital, half of which was raised by the clubs in the Doncaster area and matched funded by the LCIF. A similar project is ongoing for the sanctuary appeal at Martin House Children's Hospice and £22,491.00 has been raised so far which will be matched funded by LCIF.

During the year, the Foundation received income from donations from Lions Clubs within the District. In 2021/2022 the total received was £148,646.31. Following a slowdown in activity during Covid the Foundations income is back and exceeding the expected levels.

The sum of £184,188.56 was expended on charitable activities during the year. The highlight was the raising of £107,660 towards the Lions Clubs International Foundation refugee and displaced persons fund following the war in the Ukraine.

## TRUSTEES' REPORT

The Trustees present their annual report together with the financial statements of Lions Clubs International District 105N Foundation, a Charitable Incorporated Organisation (the Foundation) for the 12-month period ending 30 June 2021. The Trustees confirm that the Annual Report and financial statements of the Foundation comply with the current statutory requirements, the requirements of the Foundation's governing document and the provisions of the Statement of Recommended Practice (SORP) "Accounting and Reporting by Charities" issued in March 2015.

### Structure, Governance and Management

The Foundation was registered as a Charitable Incorporated Organisation on the 3rd June 2019.

The Constitution stipulates that the minimum number of trustees shall be five and the maximum twelve. Six District Officers shall be ex-officio trustees of the Foundation, these are the District Governor, 1<sup>st</sup> Vice District Governor, 2<sup>nd</sup> Vice District Governor, District Treasurer, District Secretary, and from 1 July 2020, the Immediate Past District Governor.

There shall also be a minimum of two and maximum of six appointed trustees. No trustee can be appointed without the permission of the District Governor.

In the year 2020/2021 there have been nine trustees in post, six of whom were ex-officio officers and three appointed trustees.

The process for the appointment of trustees is stipulated in the Constitution. Any trustee may call a meeting of the trustees. Meetings of the trustees are managed in accordance with the governance of the Foundation as set out under the Charitable Incorporated Organisation Constitution.

The Foundation's insurance requirements are covered under Lions Clubs International Multiple District 105 insurance arrangements.

The trustees confirm they have complied with the duty in section 4 of the Charities Act 2006 to have due regard to the Charity Commission's general guidance on public benefit 'Charities and Public Benefit'. This year the Foundation have continued to provide public benefit, and we will explain how this has been achieved in this report.

All the administration expenses of the Foundation are dealt with through District 105N's 'Administration Account' the balance of which does not include any money raised from members of the public. The amount of expenses for travelling to meetings and room hire, for the period of these financial statements was zero as all meetings were conducted through zoom.

District N consisted of 82 separate Lions Club. Each club is autonomous and can decide on what Charitable donations they make. If a club decide to donate to a project or appeal from the international organisation, the Multiple District or the District then those funds will be channeled through the Foundation. The trustees can confirm that the only liabilities that the Foundation does have relate to funds held with the Foundation's accounts pending the progression of these projects or appeals.

During the past year the Foundation has not raised any funds directly from the public, although this is something that the Trustees may consider in the future. The Foundation has a grant making criteria, under which any applications would be considered by the trustees at their meetings.

### **Financial Review**

During the year, the Foundation received income from donations from Lions Clubs within the District. In 2020/2021 the total received was £50,155.00. This was down from the previous year and entirely due to the effects of the Covid19 pandemic which limited the activities of the Lions Clubs.

The sum of £55,973.10 was expended on charitable activities during the year.


