Trustees Report

For the period ended 30 September 2022

Trustees present their annual report and unaudited financial statements for the year ended 30 September 2024.

The financial statements comply with the Charities Act 2011 and the organisation's Constitution.

Charitable operations

The Trinidad and Tobago Health UK Forum (TTHUF) is a registered charity, established for the public to benefit from the relief of sickness and the preservation of health in Trinidad and Tobago, the Commonwealth and non-Commonwealth countries.

Structure, governance and management

TTHUF is a Charitable Incorporated Organisation (CIO), founded in 2017. TTHUF was registered as a charity on 3 June 2019 and entered onto the Register of Charities with the Charity Registration Number 1183695.

The TTHUF Board is currently made up of 6 Trustees, an increase of 1 during the term. There can be a maximum of 15 trustees. The day-to-day running of the organisation is led by Trustees including the Chair, Secretary and Treasurer, all of whom are volunteers. Other Trustees play a vital role in ensuring that the charity achieves its objectives.

The diversity of the appointed Trustees provides a variety of skills, knowledge, experience, and qualifications relevant to the aims of the charity. There were 6 Board meetings during the year. Meetings occurred virtually via zoom. Trustees are responsible for the overall direction of the charity and for the development of its policies. The TTHUF constitution makes clear, the responsibilities and procedures for reporting decisions, actions and issues, including recruitment and induction of new Trustees.

Risk management

Trustees have overall responsibility for ensuring that the charity has appropriate systems of control, financial or otherwise.

As it was last year, there continues to be a challenge in accurately recording minutes of meetings. Board meetings were video recorded, with action points written by a volunteer.

Summary of the year

The report covers the period 1 October 2023 to 30 September 2024.

Whilst Trustees remain focused and committed to TTHUF's purpose, this year has been a tough year for the charity.

The Board continued to meet virtually via Zoom. There were virtual members meetings during the year. Board members have not had a face-to-face meeting since February 2020.

There continues to be not much contact between the Trustees and key health officials contacts during the year. This continues to be a challenge as there is a total lack of engagement from potential partners in Trinidad and Tobago.

However, TTHUF continued to have regular engagement with Ora Gordon, to work together to provide the Angel bra, to post- mastectomy women in Trinidad and Tobago and the Caribbean, at affordable prices.

Ora referred to the assistance TTHUF gives to women in Trinidad and Tobago on television. Not by name, but it was clear that it was TTHUS she was referring to.

The focus for the charity in the past year has been:

Memorandum of Understanding with Ora Gordon

TTHUF and Ora Gordon continued to work together to provide the Angel bra, to post- mastectomy women in Trinidad and Tobago and the Caribbean, at affordable prices.

During the year, we supplied 2 women in Trinidad and Tobago, 2 pairs of angel bras and 2 prosthetic softies. We also supplied 1 prosthetic softie, to woman who was supplied the wrong size last year.

This collaboration with Ora Gordon recognises that by working in collaboration, we can address an unmet need for breast cancer survivors, whilst boosting their self-esteem and dignity.

The following are the health benefits of the Angel Bra:

1. The support each woman needs: It is specifically designed to reshape the bust, heighten the natural beauty, protect the back to obtain the correct position and to redistribute weight.

2. A bra with a difference: It is made with the highest standard of quality that is recognised internationally. It is scientifically designed forging ahead with a new concept in remodelling. It loads 25% on the shoulders and 75% is absorbed by the suspension system by ensuring that the spinal column is raised and in the correct position.

3. Its unique benefits:

- Reaffirms and reshapes location
- Increases volume
- Unloads the weight from shoulders and relaxes the muscles of the back
- Your best defense against gravity
- Alleviates bust tenderness
- Improves posture

4. A seven in one bra with a unique design and allows the bust to: minimize, maximize, equalize, support/ sports bra, pregnancy/nursing, post-surgery and prosthesis.

5. Complements each stage of a woman's life: youth, adolescence, maturity, pregnancy, nursing and post-surgery.

6. Aids in the prevention of cysts formation and breast cancer.

As a result of the experts' investigation and careful analysis, the Angel Bra produces excellent benefits of great aesthetic quality. However, the benefits of the bra are not limited to physical appearance and boasts psychological benefits as well. The Angel Bra increases self-esteem by promoting positive body image which is a significant factor to one's overall well-being.

Ora Gordon will serve as the sole distributor of the Angel Bra to the TTHUF and will provide the goods at a wholesale price.

TTHUF has a Standard Operating Procedure (SOP) for donating the Angel bra for qualifying women in Trinidad and Tobago. A SOP is a set of written instructions that describes the step-by-step process that must be taken to properly perform a routine activity.

Fundraising

TTHUF had 1 charity fundraiser during the year. This was a Trinbago cuisine summer event in July 2024.

The event realised a profit of £714.40, despite attendance being disappointing and being much less than previous Curry-que fundraisers. The profit was influenced by:

- Catering team not charging TTHUF for ingredients and drinks for the event
- A 40% commission deduction from Eventbrite for sales on their platform

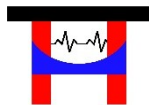

Financial review

The Trinidad and Tobago Healthcare UK Forum herein after referred to as “TTHUF” or “the charitable company”, continues to be in a healthy financial position.

TTHUF officially became a charity registered with the Charity Commission in June 2019. The first official annual financial report was filed with the Charity Commission in June 2021.

According to the Charity Commission’s website, *“This is a newly registered charity - accounts and annual return not required yet. The charity does not need to update its information until 10 months after its first financial period ends.”*

This financial report covers the period 01/10/2023 to 30/09/2024. This is to bring it in line with the Charity Commission’s period of reporting. Previous financial reports can be found at the TTHUF website: (<https://www.tthuf.org.uk/annual-report-and-finacial-statement>)

The charity’s work is reliant on income from its charitable activities. The main source of income for the reporting period remains as its membership fees. At the start of the charity’s reporting period (01/10/2023) there was a balance of **£10,435.77** in the account. A breakdown for the reporting period is **£1404.90** income and **£1340.38** expenditure.

The charity continues to meet its financial objectives in generating a small surplus and is financially sound with the balance sheet showing total charity funds at the end of the reporting period as **£10,495.29**. *(The calculation above will show a closing figure of £10,500.29. There is always a £5.00 difference which is due to the time when the bank updates its online records of the account. The monthly and quarterly financial updates always reflect the contents of the online bank statements).*

The charity currently does not have any fixed assets or investments to report.
