To offer RDA Carriage Driving, one-to-one high impact equine interventions and rural crafts/therapies to young people and adults (from the age of 8yrs old) who will gain some therapeutic benefit/wellbeing from one or a range of the activities that we offer.

**Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)**

In February 2020, the premises was approved by RDA National Assessors and we then began actively working towards a formal start date in July 2020. However, all our plans had to be put on hold as March 2020 was the start of the National Lockdowns due to the Covid 19 pandemic.

Since February 2020, we have been unable to formally open, due to the pandemic and our efforts have been to ensure we were in a position to open, once government lockdowns allowed.

We have maintained buildings and managed the land, cared for the various animals on site, worked with small numbers of volunteers and updated our safety procedures to incorporate covid protocols.

All of our therapeutic sessions are outdoors and the cold and wet winter months would have naturally, drawn a close until the spring. Our intention is to formally open in the spring of 2022.

The Trustees and CEO are extremely grateful for the tireless efforts made by the few volunteers inducted at the start of 2020 in preparation for our official RDA assessment and audit and who have continued to be involved to date, allowing the Charity the opportunity to wait until covid restrictions and the spring weather allow the charity to operate with clients.

- Renovating and making safe, new premises.
- Daily animal welfare and land management.
- Training of key personnel and equines
- Resilience in overcoming flooding and Covid Restrictions.
- Resilience in maintaining a presence having to postpone a formal opening until Spring 2022.
- Offering one-to-one sessions free of charge to support mental awareness during pandemic. A total of 28 people were supported with equine sessions and supported volunteering sessions.
