The Charity has a team of Managing Trustees who are the designated Elders of the Church and are appointed by plenary meetings of the whole Church Membership.

The Charity is a member of an association called the Fellowship of Independent Evangelical Churches, which has no management responsibility or control over the Charity but purely acts as a consultative body.

The Managing Trustees regularly review financial, operational and personnel risks and have implemented various policy documents to manage risks at a low level. All staff members must be familiar with these policies and comply with them. Any breaches of the safeguards and other irregularities are investigated thoroughly.

## Section C Objectives and activities

**Summary of the objects of the charity set out in its governing document**

The objects of the Charity are the following:-

- (a) the advancement of the Christian faith in accordance with the Doctrinal Basis of Faith primarily but not exclusively within Reading and the surrounding neighbourhood; and
- (b) such other charitable purposes as shall, in the opinion of the Members in a Church Meeting, further the work of the Church and put into practice the teaching of the Bible.

Such advancement of the Christian faith and other charitable purposes shall be undertaken in a manner consistent with the Doctrinal Basis of Faith, the provisions of this Constitution and the Church Handbook, including without limitation the Doctrinal Distinctives and Ethical Statements, as may be current from time to time.

**Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)**

The Charity was registered in June 2019 and is a CIO which is intended to be the successor Charity of Carey Baptist Church, Reading, an unincorporated charitable association, registered number 1126468. The assets had not been transferred to the CIO by 31 December 2020 so that the CIO had not commenced operation by the end of 2020.

However, the intentions of the charity can be summarised as follows in order to meet the requirements of its objects:-

Conduct regular Sunday worship and a biblical preaching ministry which is open to all and accessible to those unfamiliar with the Christian faith and those for whom English is not their first language. This will be on our own premises and/or on-line so that listeners can benefit both elsewhere in the UK and overseas.

Conduct a comprehensive programme of teaching and activities for children, young people and students on Sundays and during the week.

Hold regular, normally weekly, meetings for prayer, Bible study and fellowship and promote informal contact and friendship between members and others.

Hold regular, normally every two months, meeting for members of the Charity.

Use our premises to provide a facility such as weekly mother and toddler groups open to all and an informal meeting place for people from the local community.

Provide a substantial lunch at a low cost for senior citizens normally weekly as well as an opportunity to find out about the Christian faith and to chat informally.

The Trustees will pay due regard to the Charity Commission's guidance on public benefit and the Church will ensure that a distinct public benefit is provided in our activities. A spiritual or practical benefit will be provided to a wide range of members of the public in most of the activities outlined above. The benefits will hopefully include some people coming to a personal faith in the Lord Jesus Christ as their Saviour and a transformed direction for their lives.

No doubt there will be tangible benefits in personal and family relationships as a consequence of the application of Bible teaching. Support will also be given to people with personal and relationship problems.

In addition, effort will be directed towards providing education and facilities for young people as well as promoting friendship and good community relations to all, including those from overseas and elderly people.

We intend to use our premises and facilities essentially free of cost in the service of the local people.

Our vision for providing public benefit is not limited to our UK activities and we intend to contribute both financially and through our members working as missionaries promoting the Christian faith, providing education, developing clean water resources, improving medical facilities and the relief of poverty and hardship in several parts of the world.

While our intention is to interact freely with Church members and others in person we will comply with any Government and local restrictions and conduct meetings and all the activities mentioned above on-line, if possible, during the current pandemic and any lockdown constraints.

The charity has concern for the spread and flourishing of the Christian gospel overseas and to this end it is the intention to continue supporting a number of members who are working overseas in various capacities. These members are and will continue to be supported to some extent by Carey Baptist Church.

The Church also makes grants to support practical and spiritual needs both in the UK and overseas which are in line with our Charity's purposes and objects as assessed by the Managing Trustees.

The reserves policy of the precursor Charity, Carey Baptist Church, Reading, registered charity number 1126468, is that the unrestricted funds should be maintained at a level equivalent to between three and six months' expenditure. It is the intention of the Managing Trustees of the CIO to continue to apply this reserves policy.
