Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	<p>Fitzjohns connects those in our local community with spare time to share with those who could use a little help. Open every Monday afternoon at Christ Church, its activities have become more important given the emergence of the cost of living crisis, and the foodbank has extended its role to work more closely with other agencies including the District Food Partnership to provide further support for clients.</p> <p>Fitzjohns members come to us for a variety of reasons – some have been temporarily left without income due to job loss or benefit change, others affected by house moves or relationship change. Many are struggling with ill-health, disability, low or unreliable wages or insufficient benefit levels.</p> <p>Between 1st Aug 2023 and the 31st of July 2024 the number of households we support has fluctuated, but on average we had 80 households registered and served around 50 households each week, providing at least 2 days' worth of dry and fresh provisions, typically to a value of around £35-£40, plus essential household items such as cleaning materials, toiletries, pet foods and baby products.</p> <p>One of our key achievements last year was to successfully change our mode of operation to that of an affordable food club.</p>

		<p>All new members are provided with six weeks of support. Members that require further support after the initial six weeks are asked for a £3.5 contribution. This contribution helps shift the narrative of service users from passive recipients of support to members of a community food project. The contribution enables us to purchase additional food, improve the range of foods we offer, and provide additional choice to members.</p> <p>We also ingrained our community café, which provides a hot meal and drinks, as a central part of our offer. The café provides a warm space and opportunities to socialise.</p> <p>Lastly, the foodbank also provides volunteer opportunities to around 36 people, enabling social connection and contribution.</p>

Review of the charity's financial position at the end of the period	Para 1.21	<p>The foodbank made a comfortable surplus overall in 2023-24. The charity has again been able to commission the services, via another charity, of a paid coordinator on a permanent basis, and of two additional paid coordinators, currently on a one year basis. These commitments have been entered into on the understanding that they will eat into the reserves over the next financial years, so the trustees will need to monitor the level of reserves.</p> <p>On the other hand we have been able to continue the café service at a lower cost, thanks to the availability of volunteer chefs, so that we have reserves in hand earmarked for this service.</p>
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	Trustees agreed that a modest amount of funds, roughly equivalent to 3 months running costs, should be held as a minimum reserve. This policy will continue to be reviewed by trustees.
