Trustees' Annual Report for Year to 31 March 2025

The trustees are pleased to present their annual report together with the financial statements of the charity for the year to 31 March 2025. Reference and administrative information set out on page 1 forms part of this report. The financial statements comply with current statutory requirements, the charity's constitution and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Structure, Governance and Management

Governing document

Friends of ESRA in Israel is governed by a Trust Deed and constituted as a charitable incorporated organisation (CIO) and is registered with the Charity Commission as charity number 1184809. The company is governed by its Constitution.

Organisational Structure

The rules for Trustee selection are presented in detail in the Trust Deed, however the main points are:

- (a) There must be at least three charity trustees. If the number falls below this minimum, the remaining trustee or trustees may act only to call a meeting of the charity trustees, or appoint a new charity trustee
- (b) There is no maximum number of charity trustees that may be appointed to the CIO.

First charity trustees

The first charity trustees are Richard Stein, Stephen Samuel, and Roger Adelman. Charity trustees are appointed for the terms set out below.

Appointment of charity trustees

- (1) Apart from the first charity trustees, every trustee must be appointed for a term of three years by a resolution passed at a properly convened meeting of the charity trustees.
- (2) In selecting individuals for appointment as charity trustees, the charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

Objectives and activities

To provide such financial or material assistance to support the charitable work of ESRA Israel, as the trustees shall from time to time determine with particular preference for support of projects which relieve the charitable needs of children and young people.

The main activities during the year continued to be the raising of funds from the general public through fundraising activities. Additionally, education events took place to promote the work of ESRA to the wider public.

Policy on grant making

The Trustees have agreed a policy to make grants to ESRA in Israel on a twice-yearly basis: once in the Autumn and once in the Spring subject to an acceptable form of application and not limited to twice a year if appropriate.

Achievements and performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole

*"The Trustees and the Committee have continued to raise funds from donors across the UK for the registered Israeli Charity **ESRA – English Speaking Residents Association** (Charity Registration No: 580037455). The **Student Build a Community Project** ("the Project") is currently the main beneficiary of semi-annual grants from the Charity, and funding is also made available to promote the **English Tutoring Program** ("the Program").*

The income, generated in the UK from donations, has contributed to easing the pressure on the Project resulting from the political situation in Israel. Despite extreme difficulties, the Project continues to act in cooperation with local municipalities to provide housing accommodation for university students in disadvantaged neighborhoods in return for those students mentoring local schoolchildren. This process also enables the students to learn leadership skills and take a lead in local community affairs while obtaining their qualifications from institutes of higher learning.

Regarding the Program, there has been a successful drive in the UK to recruit suitable volunteers to act as online tutors in English for Israeli schoolchildren from all sectors of society - Jewish (Secular & Religious), Arab, Bedouin, etc. Additionally, the program provides an opportunity for teachers of English in Israel, for a short time each week, to talk, in person, to native English speakers, which they are often unable to do. Israeli teachers themselves can include this as part of their "in-service" training. The number of UK volunteer tutors has continued to grow, and there have been meetings held in the UK presenting opportunities for them to meet and exchange their experiences.

Any Gift Aid amount recovered on a donation is considered to be part of that gift and is treated as an addition to the same fund as the initial donation unless the donor or the terms of the appeal have specified otherwise.

Assets

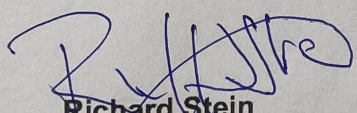

The Students Build a Community Project.

ESRA's Students Build a Community project, in cooperation with local municipalities, provides financially stressed students with housing in disadvantaged neighbourhoods. In return, the students each mentor a group of four challenged local schoolchildren and become social leaders in the community. The project operates across 6 neighbourhoods in Netanya, Akko and South Tel-Aviv-Yaffo.

As a result of the impact of the work, which is supported in part by a grant of £42,250 provided by The Friends of ESRA in Israel, 87% of the 213 schoolchildren who took part in the project expressed a feeling of increased self-confidence, and all the 58 student mentors completed their degrees with

most becoming social activists. In total, 14,500 Community Students volunteer hours were invested in raising the quality of life and helping the population in needy neighbourhoods.

The English Tutoring Program

This volunteer driven project connects Israeli teenagers who wish to practise their English skills with English speaking volunteers from across the world. The Friends of ESRA in the UK works closely with our partners, The Jewish Volunteers Network to help promote the opportunity to volunteer on the programme – and in the last year, over 78 UK based volunteers held weekly 40-minute chat sessions with 8th-12th grade students, with a focus on improving English oral skills. The total number of hours invested by the UK volunteers is calculated as being in excess of 2,300 hours over a 30 week period.

Basis of Preparation

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The accounts have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and with the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

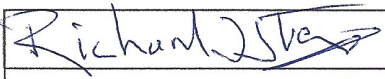
