With these adjustments it was not practicable to send shipments to the school, nor to access other schools in the region to send shipments to as they also remained closed for the most part during the reporting period.</p> <p>Trustees have remained in close contact with the school to understand their emerging and ongoing needs in order to see where the charity could identify how best to fulfil the objects once schoolchildren returned to the classrooms.</p>
