This meant that we were unable to fundraise in the conventional ways face-to-face and also limited us being able to rehome dogs. During this period, we focused on the future for the rescue and got our website redesigned and purchased a new vehicle to enable us to continue our work more efficiently once restrictions are lifted. Despite challenges due to lack of fundraising opportunities we continue to be in a good position financially and have generous supporters of the charity.</p>
