- To advance education in such ways and in such parts of the United Kingdom or the world as the Church Council from time to time may think fit.

2. SUMMARY OF PERFORMANCE AND ACHIEVEMENTS

In order to achieve our objectives, some of the main activities and accomplishments taken during the financial period are as follows:

- The charity serves its members and the community by performing the expected religious services such as, Weddings, baby blessings, funeral etc.

- Our social activities got lonely people out to socialise and cut boredom.
- In other to support those in need, the church has supported members and non-members with welfare donations which helped some people pay for rent, purchase food and other needed materials.
- The charity offers emotional support for all who are in need through counselling, this is done with an understanding heart and we do so to support members in all areas of life.



6. Bad debts

In the accounts submitted previously for the 2023-24 period, a figure of £9641 was considered as bad debt. This was an error. The charity operates on a receipts and payments basis and as such no bad debts should be recognised in the accounts.

7. Going Concern

The charity is operating on a going concern basis and will continue to operate as such into the foreseeable future. For the year ended 31 March 2024, after the bad debt figure has been reconciled, the total funds carried forward show a net fund of £7,490.

8. Prior Year Closing Fund Discrepancy

The trustees acknowledge that the closing fund balance reported in the 2023 Annual Return and accounts filed with the Charity Commission (£11,843) does not match the opening fund balance used in these 2024 accounts (£17,295). This variance arises from differences between the charity's internal financial records (maintained in FreeAgent) and the previously filed accounts for the year ended 31 March 2023. The trustees have taken steps to ensure that the 2024 accounts presented here accurately reflect the charity's actual bank and cash position at 31 March 2024. The trustees will consider restating or clarifying prior year figures in future reporting periods if necessary.


