Their dedication was demonstrated in numerous complex rescues — including the safe recovery of a stranded swan from Ormesby Pond, a trapped wood pigeon, and multiple hedgehogs and bats requiring urgent treatment.</p> <p>Volunteers also played a vital role in transporting animals to veterinary care, supporting the charity's education projects, and fundraising at local community events such as the Hemsby Family Fun Day and Ormesby Village Fête.</p> <p>Despite limited facilities and staffing during the year, our volunteers continued to respond to public calls, manage the charity's domestic section, and support the development of new community initiatives such as wildlife communication apps. Their compassion, persistence, and willingness to work in challenging conditions — often knee-deep in mud, soot, or rain — embody the spirit of Runham Wildlife Rescue and make our work possible.</p>





