TRUSTEES' REPORT
FOR THE YEAR ENDED 30 JUNE 2023

The trustees present their annual report together with the financial statements of Holocaust Learning UK for the twelve months to 30 June 2023.

The annual report serves the purposes of both a trustees' report and a directors' report under company law. The trustees confirm that the annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the Charity qualifies as small under section 382 of the Companies Act 2006, the Strategic Report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Holocaust Learning UK (HLUK) was incorporated on 20 June 2019, and its principal activities during the period under review were educational events centred on Holocaust Memorial Day ("HMD") 2023, and which are reported more fully below.

Reference and administrative information are set out on page 1 and form part of this report. The financial statements comply with current statutory requirements, the articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

a. Purposes and aim

HLUK's objects, being for the public benefit, are the advancement of education of future generations about the causes and the history of the Holocaust, and to raise awareness of the lessons from the Holocaust and subsequent genocides and their relevance to society today.

HLUK achieves its charitable objective by providing a unique opportunity for young people to hear the testimony of a Holocaust survivor and/or one of their descendants using the medium of filmed testimonies to explore the underlying issues of racism, bullying and discrimination that still resonate today.

The trustees review the aims, objectives and activities of the charity each year. This report looks at what the charity has achieved and the outcomes of its work for the reporting period. The trustees review the success of its activities and the benefits the charity has brought to those groups of people that it is set up to help. The review also helps the trustees ensure the charity's aims, objectives and activities remained focused on its stated purposes.

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning its future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives that have been set.

b. Operational report, HMD 2023

Review

Our original educational programme, (which ran from 2001 – 2019), was based on school parties being invited to visit our partner synagogues, wherein students participated in a carefully designed programme, combining a substantial workshop element together with the opportunity to hear the personal story of a Holocaust Survivor.

The impossibility of continuing this approach during the Covid pandemic lockdown prompted us to develop educational films, (for screening in the classroom or at home during lockdown restrictions), specifically designed for secondary school students, our target audience. The films aim to give students a sound understanding of the Holocaust and its historical context in tandem with the vivid story of a survivor. They offer a compelling combination of survivor testimony, historical archive footage, and the participation of student actors and presenters. Perhaps uniquely within this sector, our films aim to fulfil national curriculum requirements for Holocaust education either with teacher-guided classroom discussion, or, where this is not possible, to provide a stand-alone alternative, assimilable to students from year 8 and above without active teacher guidance or direction, should the latter be unavailable within any given mainstream secondary school.

These films have proved hugely successful. By 2022-2023, we had evolved from a small, local north-west London and environs organisation providing in-person events to some 50 schools, to a nationwide, fully-fledged charity producing and distributing Holocaust education films to hundreds of schools and thousands of students throughout the UK and beyond. We have a strong marketing drive in the build-up to Holocaust Memorial Day, but our films are available to stream from our website for classroom and assembly use throughout the school year.

Our first film, *Janine's Story*, was made in time for Holocaust Memorial Day 2021, via a unique partnership with the film production company, Tapestry Pictures. Tapestry's original expertise in creating films for schools and for family memoirs enabled them to understand our remit completely and their care, ingenuity and expertise has supported our creation of three further films. Each film is based upon HLUK's commitment to providing a stand-alone Holocaust educational resource but each is distinct in terms of testimonial content and perspective.

Our second film, *Assembly Film*, was created in partnership with Tapestry for Holocaust Memorial Day 2022. Created specifically for secondary schools' assemblies commemorating Holocaust Memorial Day, it features the testimony of 6 survivors and offers a pan-European overview of the Holocaust in the context of World War II.

In 2022, we created the third film, *Steven's Story*, which features Amsterdam-born Survivor, Steven Frank, and follows him from infancy to the end of the War. Made for secondary school age students from school year 9 and over, the film, which lasts just under an hour, weaves in the story of Anne Frank, Steven Frank (no relation) and other survivor testimonies read by young actors. There is moving archive footage and first-hand testimony from Steven, who is a charismatic and compelling presenter. It is unforgettable.

The film ends by bringing in modern examples of antisemitism, white supremacy and hatred against other groups, including Islamophobia, anti-Black racism, homophobia, transphobia and the oppression of the Uyghurs.

Made by Tapestry Pictures, and with narration by Jason Isaacs, *Steven's Story* proved to be a valuable addition to the two films already produced by Holocaust Learning UK: *Janine's Story* and *Assembly Film*.

All Holocaust Learning UK's films are offered completely free of charge to schools. Moreover, as the charity's reach has grown, so we have included on our website (at no charge) teaching resources for schools' use. These resources have been offered via our partnership with the Holocaust Educational Trust.

The Holocaust Educational Trust has also provided script and content oversight for our films, ensuring that accurate and informed historical, educational and pedagogic standards are maintained within all films. We are

hugely grateful and indebted to the Holocaust Educational Trust for their continuing support, expertise and encouragement.

The Jane Goodman Charitable Trust was so impressed by *Janine's Story* and by the need to capture as many testimonies as possible whilst survivors are still with us, that they gave us a grant allowing us to film, in depth, nine more survivors. With this generous support, we are producing an archive to be used in further educational projects; much of this filming has now been completed.

By the end of the academic year 2022-2023 (July 2023), the numbers of school registrations and students viewing Holocaust Learning UK films had exceeded all previous achievements. By the academic year end, in excess of 63,000 students had viewed one or more of our three films: *Janine's Story*, *Steven's Story* and our *Assembly Film*.

During the year we established our Advisory Council: experts from within the fields of Holocaust education; teaching; community and national politics; faith; museum production; marketing and advertising. As we moved into the new academic year 2023-2024, the support and guidance of our Advisory Council proved invaluable and we are hugely grateful to all its members.

Achievements and performance

a. Evaluations of the 2023 HLUK Events

Since our earliest days we have evaluated our activities year on year. This is done via teacher evaluation questionnaires and student evaluation questionnaires, designed with the help and guidance of Dr Jennifer Mindel, Professor of Public Health, University College London.

Sadly the teachers' and students' response rate to our 2022-2023 programme was insufficient to allow for statistical analysis. However, the responses that were received were all highly positive. The following quotations from the evaluations give a flavour of how our films have been received:

c. Beneficiaries of our services

We consider the beneficiaries of our services to be the students who attend our Holocaust education programmes. We measure the benefit provided through the post-HMD surveys detailed above.

Financial review

a. Introduction

The trustees are satisfied with the outturn for the financial period. HLUK received donations totalling £104,630 (2022 - £122,739) during the period under review. Cash balances at the beginning of the year totalled £74,290. HLUK costs during the period were £62,595 (2022 - £49,122), resulting in an income surplus of £51,935 (2022 - surplus of £73,617). Deposit and current cash balances at the period end totalled £126,225.

b. Reserves policy and going concern

On 30th June 2023 HLUK had reserves totalling £126,225 (2022 - £74,290). The trustees consider the reserves at the year-end sufficient to support the ongoing activities of the Charity during the financial year to June 30th 2024. The trustees have committed to a policy whereby all activities of the charity are fully funded before commitments are entered into.

c. Principal risks and uncertainties

The principal risks and uncertainties facing HLUK are:

- that HLUK will not be able to raise sufficient funding to carry out its educational programmes. This will be addressed by ensuring that all HLUK programmes are fully costed and budgeted within the financial resources of HLUK.
- that teachers and students will fail to maintain interest and engagement in Holocaust education. This will be addressed by the presentation each year of a new and relevant theme for HMD, and by the creative ways in which the HLUK team develop programmes of engagement.
- that Holocaust survivors are reaching the end of their lives and that consequently there are fewer survivors able to contribute to our work and to present their testimonies in our HMD presentations. This will be addressed by developing a filmed archive of survivor testimonies, by maintaining a close working relationship with the Association of Jewish Refugees (AJR), and by exploring ways in which HLUK can involve second generation survivors in future programmes.

Structure, governance and management

a. Constitution

HLUK is a company limited by guarantee, incorporated in 2019 under the Companies Act 1985, Registration No 12082336, and registered under the Charities Act 2011, No 118887, in 2019.

b. Methods of appointment or election of Trustees

The number of trustees is not limited by the charity's Articles of Association. The trustees consider the optimum number of trustees to be up to fifteen, to reflect the skill sets required by trustees based on an annual skills assessment of the Board.

In line with good practice the charity will continue to seek and appoint trustees with appropriate skills for strong governance. New trustees will be sought by direct approach and by more informed methods of search; promising candidates will be interviewed by a panel of trustees.

d. Organisational structure and decision-making policies

HLUK is committed to a continuous programme of governance review and improvement. The trustee board has reviewed the Charity Governance Code for smaller charities and how it applies to HLUK. The trustees have formally adopted the Code and, for each of the seven principles, will apply the Code and ensure that HLUK policies are updated to reflect current practice.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 7 to the accounts.

The operational activity of HLUK is carried out by the members of the HLUK Committee: all Trustees are members of the Committee. The Committee is supported by a network of volunteer helpers, who carry out a range of tasks including the administration of online registrations by schools and colleges. The HLUK volunteers are unstinting in their efforts to ensure the success of the HLUK educational programmes. The Trustees are enormously grateful for their work.

Barbara Cohen retired as our founding Trustee and Chair on 8th June 2023. HLUK was founded in 2019, and during the period since it has enjoyed significant growth in reach, impact and stature. We are now recognised as a significant and successful operator in the field of Holocaust education, and this is in no small part due to Barbara's vision, energy, passion and leadership: we thank her for this.

We are delighted that Dr Susan Krasher has been appointed Chair. Sue is a Clinical Psychologist, and has a background in child and adolescent psychology. We look forward to further growth of our activities under Sue's leadership.

HLUK established its Advisory Council during the year. Advisory Council members, all leaders in their fields, provide specialist knowledge, expertise and advice to support Holocaust Learning UK on an honorary, ad hoc and as-needed basis. We are privileged and deeply grateful to our Advisory Council members for their support.

e. Policies adopted for the induction and training of trustees

New trustees undergo an orientation to brief them on their obligations under charity and company law, the content of the Articles of Association, the committee structure and decision-making process, the operational strategy, current issues and recent financial performance of the charity. Trustees are encouraged to attend board workshops and appropriate external training events where these will facilitate the undertaking of their role.

f. Pay policy for key management personnel

HLUK does not have any paid employees, all its activities are carried out by volunteers.

g. Fundraising compliance

Under the fundraising reporting requirements for The Charities (Protection and Social Investment) Act 2016 the Charity confirms that it does not engage in public fundraising and does not use professional fundraisers or commercial participants. The Charity has not received any complaints relating to the Act during the year.

**STATEMENT OF TRUSTEES' RESPONSIBILITIES
FOR THE YEAR ENDED 30 JUNE 2023**

The trustees (who are also the directors of the Charity for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the trustees to prepare financial statements for each financial year. Under company law, the trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the Charity and of its incoming resources and application of resources, including its income and expenditure, for that period. In preparing these financial statements, the trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP (FRS 102);
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards (FRS 102) have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in business.

The trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

In so far as the trustees are aware:

- There is no relevant information of which the charitable company's independent examiner is unaware
- The trustees have taken all steps that they ought to have taken to make themselves aware of any relevant information and to ensure that the independent examiner is aware of that information
- The trustees are responsible for the maintenance and integrity of the corporate and financial information included on the charitable company's website. Independent Examiner's Report to the Trustees of Holocaust Learning UK ('the Charity')

I report to the charity Trustees on my examination of the accounts of the Charity for the year ended 30 June 2023.

Responsibilities and Basis of Report

1. General information

Holocaust Learning UK is a company limited by guarantee, incorporated in England and Wales, registration number 12062336. The address of the registered office is C/O Clintons, 2 St. Giles Square, London, WC2H 8AP.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Holocaust Learning UK meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe adequate resources exist to enable it to meet its working capital requirements for at least twelve months from approval of these financial statements.

2.3 Income

All income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

The recognition of income from legacies is dependent on establishing entitlement, the probability of receipt and the ability to estimate with sufficient accuracy the amount receivable. Evidence of entitlement to a legacy exists when the Charity has sufficient evidence that a gift has been left to them (through knowledge of the existence of a valid will and the death of the benefactor) and the executor is satisfied that the property in question will not be required to satisfy claims in the estate. Receipt of a legacy must be recognised when it is probable that it will be received and the fair value of the amount receivable, which will generally be the expected cash amount to be distributed to the Charity, can be reliably measured.

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

2. Accounting policies (continued)

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Charity's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.

2.5 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of six months or less from the date of acquisition or opening of the deposit or similar account.

2.6 Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.7 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

Investment income, gains and losses are allocated to the appropriate fund.

TRUSTEES' REPORT
FOR THE YEAR ENDED 30 JUNE 2022

The Trustees present their annual report together with the financial statements of Holocaust Learning UK for the twelve months to 30 June 2022.

The annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the Charity qualifies as small under section 382 of the Companies Act 2006, the Strategic Report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Holocaust Learning UK (HLUK) was incorporated on 20 June 2019, and its principal activities during the period under review were educational events centred on Holocaust Memorial Day ("HMD") 2021, and which are reported more fully below.

Reference and administrative information are set out on pages 1 and 2 and form part of this report. The financial statements comply with current statutory requirements, the articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

a. Policies and objectives

HLUK's objects, being for the public benefit, are the advancement of education of future generations about the causes and the history of the Holocaust, and to raise awareness of the lessons from the Holocaust and subsequent genocides and their relevance to society today.

b. Strategies for achieving objectives

HLUK achieves its charitable objective by providing a unique opportunity for young people to hear the testimony of a Holocaust survivor and/or one of their descendants using the medium of filmed testimonies to explore the underlying issues of racism, bullying and discrimination that still resonate today.

The trustees review the aims, objectives and activities of the charity each year. This report looks at what the charity has achieved and the outcomes of its work for the reporting period. The trustees review the success of its activities and the benefits the charity has brought to those groups of people that it is set up to help. The review also helps the trustees ensure the charity's aims, objectives and activities remained focused on its stated purposes.

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning its future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives that have been set.

c. Operational report, HMD 2022

Review

Our previous educational programme, which was very well established, rested on face-to-face meetings with school parties being invited to visit our partner synagogues, and students taking part in a carefully designed programme, which combined a substantial workshop element together with the opportunity to hear the personal stories of Holocaust survivors. Our programme, which was constantly under review, was carefully structured with the help of professional Holocaust educators, and we remain very grateful in particular for the support of the Holocaust Educational Trust and the Holocaust Memorial Day Trust which enabled us to ensure that our programme was in line with the best pedagogic practices.

Covid, however, forced a complete rethink. We recognised, by the spring of 2020, that there was no way that we could run in-house events and that we needed to devise a way that would enable us to fulfil our remit, and of course to do so safely.

Our response to this was to develop a film, able to be screened in the classroom or at home, specifically designed for secondary school students, our target audience, which would give them a sound understanding of the Holocaust and its historical context in tandem with the vivid story of a survivor. The remit was also to show that "never again" has been a hollow vow, and that genocides have continued right up to the present day, whilst antisemitism, racism and prejudice continue to scar modern living. The lessons of the Holocaust, therefore, have a powerful contemporary relevance.

We turned to a small film production company, Tapestry Pictures, who understood our remit completely and used care and ingenuity in enabling us to make "Out of the Darkness" (now renamed as "Out of the Darkness: Janine's Story") in time for Holocaust Memorial Day 2020.

We worked with Janine Webber, a Holocaust survivor, who was wonderfully patient and cooperative, and enabled us to film at times that were safe both for her and for the film production team. As well as featuring Janine and historical film footage, we used a cast of young actors, who provided a contemporary voice and an immediate relevance for our target secondary school audience. The narration was provided by Jason Isaacs – an actor who was well known to our young audience.

The film was made available to schools from January 2021 through to the end of May 2021. As it was a remote offering, we were able to engage with a much wider number of schools – right across the UK, and overseas too – with participants in the US, Asia and Australia. Of the 278 schools registered, 245 were new schools for us. By June 2021, "Out of the Darkness" had been screened to more than 80,000 people.

The response to the film was very positive. It was received with enthusiasm by Holocaust educators, teachers, students and parents. Two legacy charities, The Jane Goodman Charitable Trust and Whickers World Foundation, were so impressed by the film and by the need to capture as many testimonies as possible whilst survivors were still with us, that they each gave us grants which allowed us to film, in depth, nine more survivors, thus producing an archive to be used by HLUK in further educational projects.

Even when the dangers surrounding Covid had receded, the Trustees felt that the way forward for HLUK was to continue making films, rather than concentrating on hosting in-person events. It was manifestly clear that our audience reach had grown exponentially, and that we were in a position to reach far more students than before.

Accordingly, since then, HLUK has made two further films. The first of which, The Assembly Film, is a fifteen-minute offering, planned to be shown in schools round about the time of Holocaust Memorial Day (27 January) and suitable for screening to the entire age-range of secondary school students. The second film, "Out of the Darkness: Steven's Story", which tells of the war time experiences of a Dutch child, Steven Frank, had been shot by the summer of 2022, but was not due to be released until the autumn of that year. Again, we used our trademark powerful testimony, archive footage and student actors to create an unforgettable record.

We have also recognised the value of making our films available to schools over a much longer period. Historically, everything we did had, as its focus, the period round Holocaust Memorial Day. We have recognised, however, that some schools also wish to use this material at other times in the school calendar, and so that is now an option available to them. This greater flexibility is an asset to our participants and so we offer our films through the school year until the end of the summer term.

Achievements and performance

a. Evaluations of the 2022 HLUK Events

We have been delivering Holocaust education programmes, either as HLUK or our predecessor organisation, for over 20 years. Since our earliest days we have evaluated our activities year on year. Each year, we have formally measured teachers' responses and students' feedback and taken comments from our volunteers to help us shape and improve future developments.

2021 was no exception, and we are very grateful to Dr Jennifer Mindel, Professor of Public Health, University College London, who agreed in an honorary and personal capacity to conduct an independent teacher evaluation of Janine's Story.

Her findings were quite extraordinary. The most common response to every single question asked was "excellent" – the highest rating available. 82% of teachers rated the accessibility of information about the Holocaust as "excellent". 92% rated as "excellent" or "good" how well the information in the docufilm was assimilated by their students. 96% rated as "excellent" or "good" the capacity of the docufilm to hold students' attention. 98% of teachers recorded that they would be "likely" to recommend Janine's Story to a colleague or fellow teacher. "I would highly recommend the film to others and hope that it is available to schools far into the future. It is a really valuable and eye-opening resource."

In 2021/2022 teachers and students evaluated the HLUK films that they saw. The results were not analysed by Dr Mindel. The pattern of very high positive feedback has continued.

Comments received from teachers included:... "really suited all age groups of a secondary school".... "Thank you for providing some very informative and emotive material for me to use with my students".... "the feedback I have received from both staff and pupils was that it was one of the best assemblies that they had had. The structure of it was excellent and I thought it did a fantastic job of explaining the chronology of the Holocaust".... "The way (it) was delivered, especially through children narrating and also the survivor testimonies, was excellent".... "Staff and students came forward to say how powerful it was and how it was the best and most meaningful assembly they had had".... "Such a good film, profound, informative, accessible but not over-emotional".... "An excellent short film which will help those not familiar with the Holocaust understand what it was...the impact it had and still has today."

b. Beneficiaries of our services

We consider the beneficiaries of our services to be the students who attend our Holocaust education programmes. We measure the benefit provided through the post-HMD surveys detailed above.

Financial review

a. Introduction

The trustees are satisfied with the outcome for the financial period. HLUK received donations totalling £122,738 (2021 - £30,938) during the period under review. Cash balances at the beginning of the year totalled £9,073. HLUK costs during the period were £49,121 (2021 - £46,839), resulting in an income surplus of £73,617 (2020 - deficit of £16,451). HLUK had also received a three-year grant, of which £8,400 is recognised during the period under review and is included in the donations figure above. Cash balances at the period end totalled £83,092.

b. Reserves policy and going concern

On 30th June 2022 HLUK had reserves totalling £74,290 (2021 - £673). The Trustees consider the current level of reserves is sufficient to support the planned programme for commissioning Holocaust education films. The Trustees have committed to a policy whereby all activities of the charity are fully funded before commitments are entered into.

c. Principal risks and uncertainties

The principal risks and uncertainties facing HLUK are:

- that HLUK will not be able to raise sufficient funding to carry out its educational programmes. This will be addressed by ensuring that all HLUK programmes are fully costed and budgeted within the financial resources of HLUK.
- that teachers and students will fail to maintain interest and engagement in Holocaust education. This will be addressed by the presentation each year of a new and relevant theme for HMD, and by the creative ways in which the HLUK team develop programmes of engagement.
- that Holocaust survivors are reaching the end of their lives and that consequently there are fewer survivors able to contribute to our work and to present their testimonies in our HMD presentations. This will be addressed by developing a filmed archive of survivor testimonies, by maintaining a close working relationship with the Association of Jewish Refugees (AJR), and by exploring ways in which HLUK can involve second generation survivors in future programmes.

Structure, governance and management

a. Constitution

HLUK is a company limited by guarantee, incorporated in 2019 under the Companies Act 1985, Registration No 12062336, and registered under the Charities Act 2011, No 118887, in 2019.

b. Methods of appointment or election of Trustees

The number of trustees is not limited by the charity's Articles of Association. The trustees consider the optimum number of trustees to be up to fifteen, to reflect the skill sets required by trustees based on an annual skills assessment of the Board.

In line with good practice the charity will continue to seek and appoint trustees with appropriate skills for strong governance. New trustees will be sought by direct approach and by more informed methods of search; promising candidates will be interviewed by a panel of trustees.

c. Organisational structure and decision-making policies

HUK is committed to a continuous programme of governance review and improvement. The trustee board has reviewed the Charity Governance Code for smaller charities and how it applies to HUK. The trustees have formally adopted the Code and, for each of the seven principles, will apply the Code and ensure that HUK policies are updated to reflect current practice.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 7 to the accounts.

The operational activity of HUK is carried out by the members of the HUK Committee: all Trustees are members of the Committee. The Committee is supported by a network of volunteer helpers, who carry out a range of tasks including the administration of online registrations by schools and colleges. The HUK volunteers are unstinting in their efforts to ensure the success of the HUK educational programmes. The Trustees are enormously grateful for their work.

d. Policies adopted for the induction and training of Trustees

New trustees undergo an orientation to brief them on their obligations under charity and company law, the content of the Articles of Association, the committee structure and decision-making process, the operational strategy, current issues and recent financial performance of the charity. Trustees are encouraged to attend board workshops and appropriate external training events where these will facilitate the undertaking of their role.

e. Pay policy for key management personnel

HUK does not have any paid employees, all its activities are carried out by volunteers.

f. Fundraising compliance

Under the fundraising reporting requirements for The Charities (Protection and Social Investment) Act 2016 the Charity confirms that it does not engage in public fundraising and does not use professional fundraisers or commercial participators. The Charity has not received any complaints relating to the Act during the year.

The Trustees (who are also the directors of the Charity for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law, the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the Charity and of its incoming resources and application of resources, including its income and expenditure, for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP (FRS 102);
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards (FRS 102) have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Charity will continue in business.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the Charity's transactions and disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the Charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

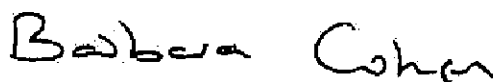
In so far as the trustees are aware:

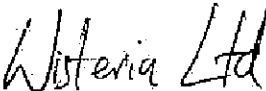
Independent Examiner's Statement

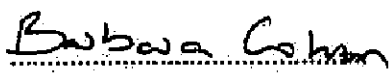

1. General Information

Holocaust Learning UK is a company limited by guarantee, incorporated in England and Wales, registration number 12062336. The address of the registered office is C/O Clintons, 55 Drury Lane, London, United Kingdom, WC2B 5RZ.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Holocaust Learning UK meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe adequate resources exist to enable it to meet its working capital requirements for at least twelve months from approval of these financial statements.

2.3 Income

All income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

The recognition of income from legacies is dependent on establishing entitlement, the probability of receipt and the ability to estimate with sufficient accuracy the amount receivable. Evidence of entitlement to a legacy exists when the Charity has sufficient evidence that a gift has been left to them (through knowledge of the existence of a valid will and the death of the benefactor) and the executor is satisfied that the property in question will not be required to satisfy claims in the estate. Receipt of a legacy must be recognised when it is probable that it will be received and the fair value of the amount receivable, which will generally be the expected cash amount to be distributed to the Charity, can be reliably measured.

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

2. Accounting policies (continued)

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Charity's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.

2.5 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.6 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

2.7 Financial Instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.8 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.

TRUSTEES' REPORT
FOR THE YEAR ENDED 30 JUNE 2021

The Trustees present their annual report together with the financial statements of Holocaust Learning UK for the twelve months to 30 June 2021.

The annual report serves the purposes of both a Trustees' report and a directors' report under company law. The Trustees confirm that the annual report and financial statements of the charitable company comply with the current statutory requirements, the requirements of the charitable company's governing document and the provisions of the Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019).

Since the Charity qualifies as small under section 382 of the Companies Act 2006, the Strategic Report required of medium and large companies under the Companies Act 2006 (Strategic Report and Directors' Report) Regulations 2013 has been omitted.

Holocaust Learning UK (HLUK) was incorporated on 20 June 2019, and its principal activities during the period under review were educational events centred on Holocaust Memorial Day ("HMD") 2021, and which are reported more fully below.

Reference and administrative information are set out on pages 1 and 2 and form part of this report. The financial statements comply with current statutory requirements, the articles of association and the Statement of Recommended Practice - Accounting and Reporting by Charities: SORP applicable to charities preparing their accounts in accordance with FRS 102.

Objectives and activities

a. Policies and objectives

HLUK's objects, being for the public benefit, are the advancement of education of future generations about the causes and the history of the Holocaust, and to raise awareness of the lessons from the Holocaust and subsequent genocides and their relevance to society today.

b. Strategies for achieving objectives

HLUK achieves its charitable objective by providing a unique opportunity for young people to hear the testimony of a Holocaust survivor and/or one of their descendants, and to work in small groups with trained facilitators to explore the underlying issues of racism, bullying and discrimination that still resonate today.

The trustees review the aims, objectives and activities of the charity each year. This report looks at what the charity has achieved and the outcomes of its work for the reporting period. The trustees review the success of its activities and the benefits the charity has brought to those groups of people that it is set up to help. The review also helps the trustees ensure the charity's aims, objectives and activities remained focused on its stated purposes.

The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning its future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives that have been set.

c. Operational report, HMD 2021

Review

Our previous educational programme, which was very well established, rested on face-to-face meetings with school parties being invited to visit our partner synagogues, and students taking part in a carefully designed programme, which combined a substantial workshop element together with the opportunity to hear the personal story of a Holocaust Survivor. Our programme, which was constantly under review, was carefully structured with the help of professional Holocaust educators, and we remain very grateful in particular for the support of the Holocaust Educational Trust and the Holocaust Memorial Day Trust which enabled us to ensure that our programme was in line with the best pedagogic practice.

Covid, however, forced a complete rethink. We recognised, by the spring of 2020, that there was no way that we could run in-house events and that we needed to devise a way that would enable us to fulfil our remit, and of course to do so safely.

Our response to this was to develop a docufilm, able to be screened in the classroom or at home, specifically designed for secondary school students, our target audience, which would give them a sound understanding of the Holocaust and its historical context in tandem with the vivid story of a survivor. The remit was also to show that "never again" has been a hollow vow, and that genocides have continued right up to the present day, whilst antisemitism, racism and prejudice continue to scar modern living. The lessons of the Holocaust, therefore, have a powerful contemporary relevance.

We turned to a small film production company, Tapestry Pictures, who understood our remit completely and used care and ingenuity in enabling us to make "Out of the Darkness" (now renamed as "Out of the Darkness: Janine's Story") in time for Holocaust Memorial Day 2021.

Janine Webber, our Survivor, was wonderfully patient and cooperative, and enabled us to film at times that were safe both for her and for the docufilm production team. As well as featuring Janine and historical film footage, we used a cast of young actors, who provided a contemporary voice and an immediate relevance for our target secondary school audience. The narration was provided by Jason Isaacs – an actor who was well known to our young audience.

The docufilm was made available to schools from January 2021 through to the end of May 2021. As it was a remote offering, we were able to engage with a much wider number of schools – right across the UK, and overseas too – with participants in the US, Asia and Australia. Of the 278 schools registered, 245 were new schools for us. By June 2021, "Out of the Darkness" had been screened to more than 60,000 people.

The response to the docufilm was very positive. It was received with enthusiasm by Holocaust Educators, teachers, students and parents. One legacy charity, The Jane Goodman Charitable Trust, was so impressed by the film and by the need to capture as many testimonies as possible whilst survivors were still with us, that they gave us a grant which allowed us to film, in depth, nine more survivors, thus producing an archive to be used by HLUK in further educational projects.

Achievements and performance

a. Evaluations of the 2021 HLUK Events

We have been delivering Holocaust Education programmes, either as HLUK or our predecessor organisation, for over 20 years. Since our earliest days we have evaluated our activities year on year. Each year, we have formally measured teachers' responses and taken comments from our volunteers to help us shape and improve future developments.

2021 was no exception, and we are very grateful to Dr Jennifer Mindel, Professor of Public Health, University College London, who agreed in an honorary and personal capacity to conduct an independent teacher evaluation of Janine's Story.

Her findings were quite extraordinary. The most common response to every single question asked was "excellent" – the highest rating available. 82% of teachers rated the accessibility of information about the Holocaust as "excellent". 92% rated as "excellent" or "good" how well the information in the docufilm was assimilated by their students. 98% rated as "excellent" or "good" the capacity of the docufilm to hold students' attention. 98% of teachers recorded that they would be "likely" to recommend Janine's Story to a colleague or fellow teacher. *"I would highly recommend the film to others and hope that it is available to schools far into the future. It is a really valuable and eye-opening resource."* - The Heath School.

b. Beneficiaries of our services

We consider the beneficiaries of our services to be the students who attend our Holocaust education programmes. We measure the benefit provided through the post-HMD surveys detailed above.

Financial review

a. Introduction

The trustees are satisfied with the outturn for the financial period. HLUK received donations totalling £22,638 (2020 - £19,255) during the period under review. Cash balances at the beginning of the year totalled £32,824. HLUK costs during the period were £46,389 (2020 - £5,450), resulting in an income deficit of £15,451 (2020 – surplus of £16,124). NHMDE had also received a three-year grant, of which £8,300 is recognised during the period under review, with the final tranche of £8,400 being recognised as a deferred grant in the Balance Sheet. Cash balances at the period end totalled £9,073.

b. Reserves policy and going concern

On 30th June 2021 HLUK had reserves totalling £673 (2020 - £16,124). Although the Trustees consider the reserves at the year-end lower than ideal, the Trustees have received intimations of Donations sufficient to support the ongoing activities of the Charity during the financial year to 30 June 2022. The Trustees have committed to a policy whereby all activities of the charity are fully funded before commitments are entered into.

c. Principal risks and uncertainties

The principal risks and uncertainties facing HLUK are:

- that HLUK will not be able to raise sufficient funding to carry out its educational programmes. This will be addressed by ensuring that all HLUK programmes are fully costed and budgeted within the financial resources of HLUK.
- that teachers and students will fail to maintain interest and engagement in Holocaust education. This will be addressed by the presentation each year of a new and relevant theme for HMD, and by the creative ways in which the HLUK team develop programmes of engagement.
- that Holocaust survivors are reaching the end of their lives and that consequently there are fewer survivors able to contribute to our work and to present their testimonies in our HMD presentations. This will be addressed by developing a filmed archive of survivor testimonies, by maintaining a close working relationship with the Association of Jewish Refugees (AJR), and by exploring ways in which HLUK can involve second generation survivors in future programmes.

d. Coronavirus pandemic

The coronavirus pandemic has challenged society on an unprecedented scale during the past two years. The pandemic became apparent shortly after HLUK had completed its educational programme for HMD 2020, and given the need for Holocaust survivors (who are now of advanced years) to shield from social contact, the Trustees decided that HLUK would be unable to operate face-to-face educational workshops with Holocaust survivors for HMD 2021. Accordingly, The Trustees developed plans for an innovative docufilm as part of an outreach programme for HMD 2021, and this is reported on above. The Trustees have decided to make available the "Janine's Story" docufilm available again for HMD 2022, together with a new HLUK production of a 15-minute Assembly Film.

Structure, governance and management

a. Constitution

HLUK is a company limited by guarantee, incorporated in 2019 under the Companies Act 1985, Registration No 12062336, and registered under the Charities Act 2011, No 118687, in 2019.

b. Methods of appointment or election of Trustees

The number of trustees is not limited by the charity's Articles of Association. The trustees consider the optimum number of trustees to be up to fifteen, to reflect the skill sets required by trustees based on an annual skills assessment of the Board.

In line with good practice the charity will continue to seek and appoint trustees with appropriate skills for strong governance. New trustees will be sought by direct approach and by more informed methods of search; promising candidates will be interviewed by a panel of trustees.

c. Organisational structure and decision-making policies

HLUK is committed to a continuous programme of governance review and improvement. The trustee board has reviewed the Charity Governance Code for smaller charities and how it applies to HLUK. The trustees have formally adopted the Code and, for each of the seven principles, will apply the Code and ensure that HLUK policies are updated to reflect current practice.

All trustees give their time voluntarily and receive no benefits from the charity. Any expenses reclaimed from the charity are set out in note 7 to the accounts.

The operational activity of HLUK is carried out by the members of the HLUK Committee: all Trustees are members of the Committee. The Committee is supported by a network of volunteer facilitators, Event helpers and booking team managers. The HLUK volunteers are unstinting in their efforts to ensure the success of the HLUK educational programmes. The Trustees are enormously grateful for their work.

d. Policies adopted for the induction and training of Trustees

New trustees undergo an orientation to brief them on their obligations under charity and company law, the content of the Articles of Association, the committee structure and decision-making process, the operational strategy, current issues and recent financial performance of the charity. Trustees are encouraged to attend board workshops and appropriate external training events where these will facilitate the undertaking of their role.

e. Pay policy for key management personnel

HLUK does not have any paid employees, all its activities are carried out by volunteers.

f. Fundraising compliance

Under the fundraising reporting requirements for The Charities (Protection and Social Investment) Act 2016 the Charity confirms that it does not engage in public fundraising and does not use professional fundraisers or commercial participators. The Charity has not received any complaints relating to the Act during the year.

Members' liability

The Members of the Charity guarantee to contribute an amount not exceeding £10 to the assets of the Charity in the event of winding up.

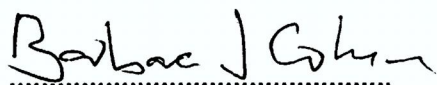

NOTES TO THE FINANCIAL STATEMENTS

1. General information

Holocaust Learning UK is a company limited by guarantee, incorporated in England and Wales, registration number 12062336. The address of the registered office is C/O Clintons, 55 Drury Lane, London, United Kingdom, WC2B 5RZ.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with the Charities SORP (FRS 102) - Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Holocaust Learning UK meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

2.2 Going concern

The financial statements have been prepared on a going concern basis as the Trustees believe adequate resources exist to enable it to meet its working capital requirements for at least twelve months from approval of these financial statements.

2.3 Income

All income is recognised once the Charity has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

The recognition of income from legacies is dependent on establishing entitlement, the probability of receipt and the ability to estimate with sufficient accuracy the amount receivable. Evidence of entitlement to a legacy exists when the Charity has sufficient evidence that a gift has been left to them (through knowledge of the existence of a valid will and the death of the benefactor) and the executor is satisfied that the property in question will not be required to satisfy claims in the estate. Receipt of a legacy must be recognised when it is probable that it will be received and the fair value of the amount receivable, which will generally be the expected cash amount to be distributed to the Charity, can be reliably measured.

Grants are included in the Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of entitlement of receipt, its recognition is deferred and included in creditors as deferred income. Where entitlement occurs before income is received, the income is accrued.

2. Accounting policies (continued)

2.4 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

Expenditure on charitable activities is incurred on directly undertaking the activities which further the Charity's objectives, as well as any associated support costs.

All expenditure is inclusive of irrecoverable VAT.

2.5 Cash at bank and in hand

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

2.6 Liabilities and provisions

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably.

Liabilities are recognised at the amount that the Charity anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

Provisions are measured at the best estimate of the amounts required to settle the obligation. Where the effect of the time value of money is material, the provision is based on the present value of those amounts, discounted at the pre-tax discount rate that reflects the risks specific to the liability. The unwinding of the discount is recognised in the Statement of Financial Activities as a finance cost.

2.7 Financial instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value with the exception of bank loans which are subsequently measured at amortised cost using the effective interest method.

2.8 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the Charity and which have not been designated for other purposes.
