Chairperson's Statement

2022 was special for me since I was able to visit Nairobi and see Fursa in action, after the Pandemic forced me to wait for over 2 years. I was filled with a huge sense of pride upon meeting the children and their parents and hearing first-hand the difference we make to their lives. It also filled me with energy and excitement, thinking about ways to grow and support many more children.

We work in a challenging environment at the best of times. In 2022, in addition to our usual challenges, we had to factor in political unrest due to elections. Our team created opportunity in the midst of uncertainty and our children drove an initiative of peace ambassadorship during what could have been a turbulent time. They are becoming role models for the future. And as an organisation, we've really grown! We now support over 60 children from upper primary through to the end of High School. The number of children transitioning to High School grew from 3 last year to 26 this year!

I'm inspired by our donors, partners, staff and volunteers who continue to rise to the challenges of the past year. They demonstrate a resilience and dedication to the community we serve. As you'll read within this report, your contributions are changing and saving lives every day — and for that, we are eternally grateful.

About Fursa

Our Vision: The Fursa Trust is committed to creating a world where all children, regardless of their background and circumstance, can lead a life of choice and opportunity.

Our Mission: The Fursa Trust provides high quality academic support, mentoring, and life skills to children from poor families living in underserved communities in East Africa, in partnership with their families, to help equip them to lead a life of choice and opportunity regardless of their circumstances.

Our Core Beliefs Define How We Work And What We Do

- Children are at the heart of our work, and all that we do is focused first and foremost on children within the community.
- Building self-esteem, aspiration, and the skills and confidence to work with others are crucial ingredients that enable and enhance academic achievement.
- Academic success creates opportunity in Kenya; access to better secondary schools depends on achievement at primary school level.
- Parents and guardians are essential partners in the work of The Fursa Trust and we all share accountability for their children's development and growth.
- Volunteers who share Fursa's values and who are committed to our vision and mission bring diversity and experience and help us achieve our objectives.
- The Fursa model is scalable through the training and empowerment of local program providers.

Children in Deep Sea face hardship and poverty in their every-day lives. This takes the form of witnessing violence and substance abuse on the streets, poverty, substance abuse and domestic abuse in the home and discrimination in school on a day-to-day basis. Research has demonstrated the impact of high cortisol levels associated with such continuous stress levels on a child's ability to learn.

- The **Afterschool club** supports students academically, socially and emotionally (help with homework and school work, mentoring, life skills, etc.), providing a safe and welcoming environment for children to come to after school every day.

- **Saturday and Holiday clubs** provide a fun and enriching environment for children to develop, learn, and imagine their future, including trips to parks and museums, meeting mentors, and inspirational community members and professionals from different fields, taking part in engaging goal setting and creative activities and performances, etc.
- **Trips** are a chance for children to see the outside world and be exposed to a world beyond their own community.
- **Parents and guardians** of children attending the Fursa clubs attend regular (monthly) meetings and workshops that build community and offer training in relevant subjects such as child development, nutrition, household and small business finances, etc.
- The Fursa Trust assists families with funding for **school tuition fees** and other adhoc costs relating to their education. The Trust has a small reserve for providing such grants directly and also builds connections with organizations in Kenya that routinely provide such support. Grants are never given directly to families, but are paid directly to schools or other providers concerned
- **Adhoc support** in response to major health or other crises that impact directly on our families, where possible developing links with community leaders and other service providers with expertise in these areas.
- **Fundraising**, primarily in the UK and Kenya, to ensure sustainable financing to support all our activities in Kenya.

Fursa is not a school and we do not try and replicate a school environment. Our focus is on supporting children in Fursa to build self-confidence and self-esteem, supporting the mindset for growth, self worth, and enabling children to participate fully in their academic learning and social journeys in their schools and with their peers. We do this through creating a safe space within Deep Sea where children have a strong sense of belonging.

Adult volunteers and staff in the club are facilitators and guides, who take time to get to know the children they work with, recognize the potential that lies within them and the struggles that they face on a day to day basis. In addition to homework help and academic support focusing on English and Mathematics, children participate in small mentorship groups, safe spaces to discuss the challenges and issues they are facing on a weekly basis. Friday is a fun day given to developing social and cognitive skills through debates, games, and other fun activities. Saturdays are given to life skills and goal-setting, including career days.

During the holidays, secondary students (currently from grades 9-11) attending boarding schools return to their homes in Deep Sea and to the Fursa club where they reconnect with their peers and facilitators. Secondary students meet at the club every morning where they are supported by volunteers and their peers with academic support, as well as a programme of fun activities. A number of them stay to mentor and help their younger Fursa peers who attend the club in the afternoon.

What was happening in 2022-2023

The new school year in Kenya in 2022 started at the end of April and ran until the end of November with just 5 weeks of planned holidays and half term breaks over the entire period. This was the third and final year of the three-year catchup from Covid – fitting three school years into just two calendar years. The start of 2023 saw the return to the usual school cycle, with most students starting back in the last week of January.

2022 was also an election year, and concerns around politically motivated violence led to unplanned school closures of over a month.

These challenges impacted the whole country, closer to home there was also the very real threat of demolition in the area of Deep Sea in 2022. In early 2022, a portion of Deep Sea was cleared and a long-planned road was completed along the upper perimeter that had two significant impacts on all families in Deep Sea:

1. The road is a four-lane street with a concrete barrier in the middle. No provision was allowed by the highways authority to allow people to cross safely by children and others to reach their schools and local shops and markets
2. A petition was submitted by developers claiming ownership rights to demolish Deep Sea for construction of high-end housing developments. The petition was appealed, but uncertainty has remained over the course of the year, exacerbated by another fire (with arson suspected) destroying homes and belongings of more than 100 families. Notices were posted on doors warning families to leave their homes and a suspected arson that decimated hundreds of mabati houses. .

And fire continues to threaten lives and livelihoods of the residents in Deep Sea. February 2023 saw another fire destroy more than 300 homes.

The year was therefore once again one of upheaval, exacerbating the existing insecurity and uncertainty faced by the children and their families living in Deep Sea in conditions of extreme poverty and insecurity.

Throughout the year, Fursa provided a bright and safe space for it's children and their families. The club was fortunately not affected by the fires, and club activities could continue, although we removed some of the more valuable assets (the solar system and computers) when the threat of demolition was felt at it's highest).

A year of consolidation

The Fursa Trust UK continued with its support for the Fursa Trust Kenya in Deep Sea over the year, providing funding and support towards the afterschool and holiday club activities to a growing number of children aged 9-19 years. Financial support from the Fursa UK supported two members of staff on payroll, as well as stipends for a crew of volunteers, some of whom have been with Fursa in Kenya for over a year. Funds were also used to provide daily nourishing snacks, learning materials (stationary, text books, etc), funding for trips, and we continue to rent Emily's Education Centre to provide space for all our students, in addition to our resource centre.

The year started with 37 students enrolled in Fursa and ended with more than 50, of whom 30 are attending secondary school (Junior Secondary and Senior Secondary schools).

As the elections came near, Fursa children worked on a peace project and created posters promoting peace within Deep Sea. It is notable that very few disturbances were seen in the community relating to the elections.

The Fursa Trust UK also assisted Fursa in Kenya to identify Pro Bono auditors (PKF) to audit their accounts for the first time.

Support to Secondary Students

In 2020, Fursa made the decision to expand the number of students it could support in Deep Sea by removing a guarantee to cover secondary school tuition fees and focus on supporting students to find funding independently. 2022 was the first year that we had a significant number of Fursa children completing year 8 who would need support with secondary school fees and related costs. Thanks to the relationship built with some visitors to Kenya, who helped the candidates prepare for their KCPE (Kenya Certificate of Primary Education) exams, we were able to develop a relationship with a philanthropist from the US who guaranteed financial support for 23 students joining secondary school in April 2022 or January 2023.

This donation accounted for approximately a third of our overall expenditure over the year. Fursa UK provided school fees for a further 4 students and an additional four students found funding through national scholarship schemes.

This has created a significant additional workload for the team in Kenya who must support (often illiterate) parents with the process of entering their children for secondary school. The Kenya government places each child within a secondary school centrally, based on their KCPE scores and their circumstance. The government supplements secondary school fees and almost all government secondary schools are boarding schools. If a parent is not happy with the placement (e.g. they may prefer a single sex school to a mixed school or the school is located too far for the family to be able to afford the transport costs across the country), they must apply to the ministry of education for a transfer. The Fursa Kenya team facilitates this but insists on the parents or guardians taking on full responsibility for the process.

Funds were provided to cover tuition fees, uniform and a mattress (all required by the schools). All funds were transferred directly to the schools of suppliers.

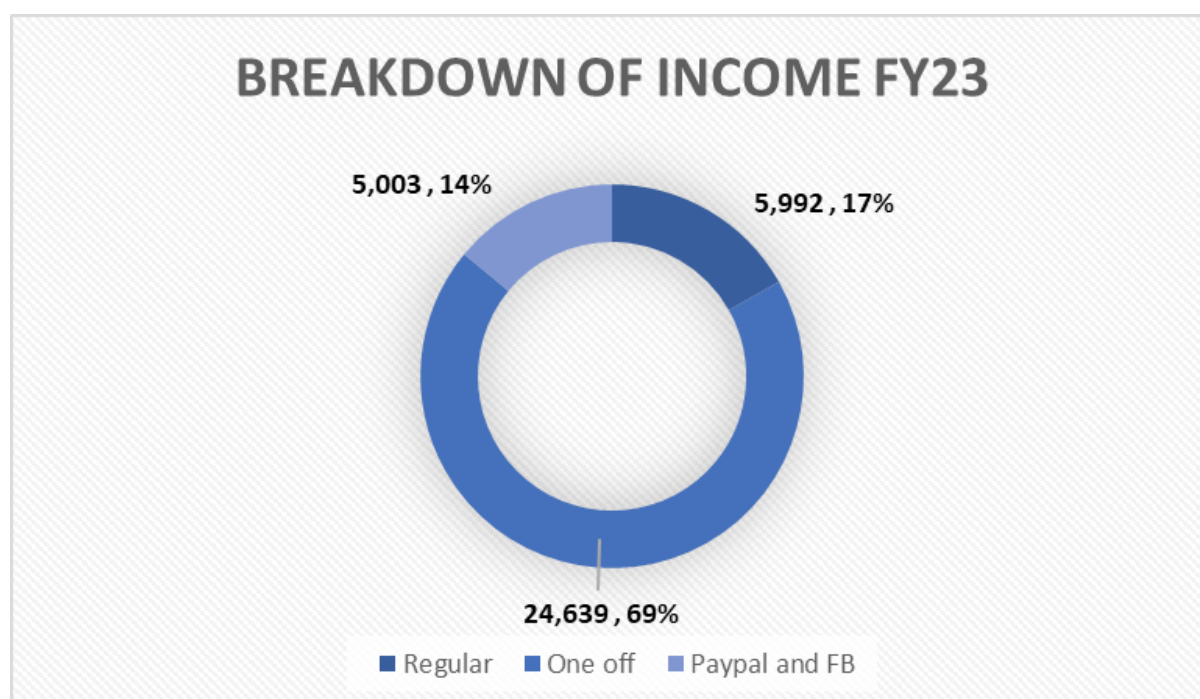
Looking ahead

In 2022, the Fursa Trust began to explore a strategy of expansion with Fursa Kenya. Two models for expansion were considered: expansion within Deep Sea and the creation of new clubs in other under served and needy areas. Given the insecurity of tenure in Deep Sea over this period, Fursa UK supported Fursa Kenya to explore expansion into other areas. This led to identifying a couple of areas for future expansion, and efforts will focus now on building up enough reserves of funds and revenue flows to be able to guarantee the costs of opening and maintaining a new club.

As we look ahead to a new year we are incredibly proud to be supporting more than 50 children in Deep Sea and their families.

Financial Statement

The number of children attending the Fursa club has almost doubled over the course of this year and the number of children attending secondary school rose to 31. Funding the tuition fees and a uniform for these children represents approximately a third of our expenses this year. The cost of attending secondary school is prohibitively high for most families living in Deep Sea; by covering tuition and the costs of a uniform, the financial demands on families are greatly reduced. This growth is reflected in our financial statements.



Fundraising

Our primary source of funds to date has been family, friends and those with a connection to Fursa. As we look to the future and reflect on how we can grow, in turn our Fundraising approach must develop. A first step in this was equipping some of the team with key Fundraising skills. We undertook a UK-Kenya fundraising course, the output of which we will implement over the course of the following years.

About Us

The Fursa Trust is a registered charitable incorporated organization, governed by a Charitable Incorporated Organisation Foundation Constitution. The only voting members are the CIO's charity trustees. Trustees are appointed by the Board of Trustees.

In all our activities, the Trustees have had regard to the guidance issued by the Charity Commission on public benefit

The Fursa Trust was registered with the UK Charities Commission in December 2019.
