Following promotion of Enfield Town FC's Men's FirstTeam to National League South in May 2024, additional funding is available from The National League Trust which will assist us greatly to continue and hopefully expand our work.

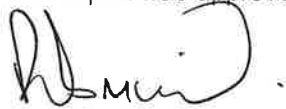

1. STATUTORY INFORMATION

Enfield Town FC Community Sports Development Limited is a private company, limited by guarantee, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements have been prepared in accordance with the Charity's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The Charity is a Public Benefit Entity as defined by FRS 102.

The Charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

Going concern

At the time of approving the financial statements, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Thus the Trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

Charitable funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

Incoming resources

Income is recognised when the Charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the Charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

Disability activities and Pupil Referral Unit

Funds have been donated for the Enfield Town FC Disability Squad and to enable us to provide coaching sessions working with the NHS for children with Cerebral Palsy and children with motor co-ordination difficulties. These funds also enable us to work with London Borough of Enfield to provide coaching for children with emotional and behavioural support needs at a local Pupil Referral Unit.

Pitching in Grant 3

A grant was received in the year from Pitching In which is allocated to the Charities activities and is treated as a restricted fund.

Keith Wortley Fund

Keith Wortley sadly passed away in December 2022. He was Life Vice President of Enfield Town FC and played a huge role in the club's formative years. His family kindly donated funds which are to be allocated to The Keith Wortley 6 a-side Walking Football Tournament.

Local Corporation

A local corporation made a generous donation of £20,000 in March 2024. £10,000 is earmarked for the longer term Youth/ Academy building project at Donkey Lane and £10,000 is for the various Disability activities.

A further donation of £10,000 was made in November 2024 towards the Youth/Academy building project.

Barclays Community Football Fund

A grant of £1,000 was received in June 2024. £225 was spent on storage facilities and £600 was spent on trainee soccer coaches.

1. STATUTORY INFORMATION

Enfield Town Fc Community Sports Development Limited is a private company, limited by guarantee, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

2. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements have been prepared in accordance with the Charity's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The Charity is a Public Benefit Entity as defined by FRS 102.

The Charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

Going concern

At the time of approving the financial statements, the trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Thus the trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

Charitable funds

Unrestricted funds are available for use at the discretion of the trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

Incoming resources

Income is recognised when the Charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the Charity has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

Adult disability squad - Germany Trip

The Charity raised funds to help with the costs of the Disability Squad in a football tournament held in Germany. Unfortunately, the 2020 tournament was cancelled as a result of the Covid pandemic. Since the year end, half of the amount raised was distributed to a local Charity, Enfield Children & Young Persons Service and half was retained for the Adult Disability Squad fund.

Disability activities and Pupil Referral Unit

Funds have been donated for the Enfield Town FC Disability Squad and to enable us to provide coaching sessions working with the NHS for children with Cerebral Palsy and children with motor co-ordination difficulties. These funds also enable us to work with London Borough of Enfield to provide coaching for children with emotional and behavioural support needs at a local Pupil Referral Unit.

Middlesex FA – Young Adults with Disabilities

Middlesex FA provided a grant to enable us to run coaching sessions at a local college for young adults with disabilities.

Pitching in Grant

A grant was received in the year from Pitching In which is allocated to the Charities activities and is treated as a restricted fund.
