PROVIDE OPPORTUNITIES FOR YOUNG PEOPLE TO OBTAIN A RANGE OF QUALIFICATIONS; ANDD. PROVIDE OPPORTUNITIES FOR COMMUNITY INVOLVEMENT.

It provides a range of activities, including sport, sailing and boat work, within a caring discipline based on the high standards of the Royal Navy, to which the young people can develop in self confidence, leadership, and a responsibility to work alone or within a team.
